

WOULD MAKE NO PLEA

Barber Rose Gives His Attorneys Trouble.

JUDGE ENTERS A PLEA

Case is Set for Trial Monday, February 8th.

Prisoner Still Defiant—His Attorneys Will Set Up the Plea of Insanity—Other Cases.

Frank Rose, the barber who confessed to the crime of uxoricide, refused to plead to the information when arraigned on the charge of murder in the first degree in the District court yesterday morning. The court ordered that a plea of not guilty be entered and the case was set for trial on Tuesday, February 8th. The refusal of the defendant to plead was the result of a compromise with his attorney, Soren N. Christensen, who, with D. N. Straup, was appointed to defend the prisoner. Rose is said to have insisted upon entering a plea of guilty to the charge. He refused to plead not guilty, but it is understood was prevailed upon to enter no plea at all. Now that a plea of not guilty has been entered it is understood that his attorneys will make a hard fight for an acquittal on the ground of insanity.

Rose was as cool and unbothered before the bar as usual. He was brought into the courtroom handcuffed with Thomas R. Fuller, charged with a felony. After the clerk had read the information Judge Morse asked of the prisoner, "What plea do you desire to enter to the charge?" The defendant advanced toward the judge's bench and answered: "I don't want to make any plea." Judge Morse then ordered that a plea of not guilty be entered and the case was set as above mentioned.

The case of the State against Arthur Brown, charged with adultery, was continued upon the court's own motion until Monday, January 18th. At 10 o'clock on that day it is expected that the defendant will be prepared to make some plea to the information against him. A plea of not guilty to the charge of rape was entered by Thomas R. Fuller, and his case was set for trial on January 18th. Attorney E. O. Leachwood was appointed by the court to defend the prisoner.

Thomas Burns pleaded guilty to the charge of burglary and was sentenced to one year in the State prison at hard labor. The defendant was charged with burglarizing the saloon at 59 West First South street.

The negro, Bud Hulman, entered a plea of not guilty to the charge of housebreaking and his case was set for trial on January 18th. Attorney Frank McGraw was appointed by the court as counsel for the defendant. The prisoner desired to plead guilty to a lesser offense, but District Attorney Elchorn refused to accept any such proposal. H. W. Engler pleaded not guilty to the information charging him with forgery and uttering a forged instrument and his case was set for January 22nd.

Before adjourning Judge Morse ordered that the seventy jurors heretofore drawn appear in court on the morning of January 18th at 10 o'clock.

FEDERAL COURT BUSINESS.

No New Trial in Allen vs. Diamond Coal & Coke Company.

There was a short session of the Federal court yesterday, with Justice Marshall on the bench, and a few demurrers were sustained. In the case of Allen vs. the Diamond Coal and Coke company, the judge denied the motion for a new trial, the fourth. The plaintiff was injured in the coal company's mine and in his first suit was awarded

damages amounting to \$5000. This judgment was set aside and the second jury failed to agree, but on the third attempt he was allowed \$3500. In the case of Kuykendall vs. the Union Pacific railroad the demurrer on the part of the Southern Pacific was sustained and the defendant took leave to file an amended complaint.

BIG DAMAGE SUIT FILED.

Street Car Company Made Defendant in \$20,000 Suit.

The Consolidated Railway and Power company is made defendant in a \$20,000 damage suit filed in the District court yesterday by Charles A. Lowry, as special administrator of the estate of Addison Whitworth, deceased. The complaint recites that Whitworth was killed on October 11, 1903, by being struck by one of the cars of the defendant. The accident is alleged to have occurred at the intersection of Second West and South Temple streets. Whitworth at the time was driving across the track in a wagon. He was thrown to the ground with sufficient force to cause almost instant death. The accident is alleged to have been due to negligence and carelessness on the part of the defendant and its employees.

The deceased left as his heirs a wife and three children.

Court Notes.

Judge Lewis will make a settling of cases in the fourth division of the District court on Friday, January 15th. District Attorney Elchorn yesterday filed an information against J. W. Kane charging attempt to obtain money under false pretenses, with the clerk of the District court. Kane is alleged to have tried to pass a bogus check for \$65 upon Thomas Pritchard in the saloon of C. Bonnett on the 15th of last November.

OIL COMPANY IS READY.

Farmington Consolidated Files Its Articles of Incorporation With the County Clerk.

The Farmington Consolidated Oil and Gas company filed its articles of incorporation in the office of the county clerk yesterday. The limit of the capital stock is placed at \$2,000,000, divided into as many shares of the par value of \$1 each. The property of the company consists of 165 placer claims, or about 16,000 acres in Farmington mining district, Davis county.

The officers of the company are as follows: Schuyler V. Shelby, president; Charles K. Rowland, vice-president; Hugh Satterlee, secretary, and Frank Knox, treasurer. These, with George H. Odell, A. C. Ewing and Elmer B. Jones, constitute the directorate.

TWO OFFICES COMBINE.

Street Railway and Light and Power Companies Consolidate Their Clerical Forces.

Extensive alterations were begun in the offices of the electric light company yesterday preparatory to the moving of the office force of the railway company, and the consolidation of the two offices. The operating departments will be in the rear of the building, while in the front part the financial ends of the four departments will be installed, i. e., gas, city electric service, light and power and railroad.

About two weeks will be required to put things in shape and move the railway offices. The directors of the new concern will meet on Wednesday in the office.

THREE VICTIMS ARRIVE.

Men Injured in the Copper Belt Disaster at Bingham Brought to Salt Lake.

Three of the victims of the Copper Belt railway disaster were yesterday brought to the Keogh-Wright hospital. All three are quite badly injured, but it is believed they will pull through without much trouble. Henry Kolman is suffering from a badly fractured left leg; John Murray has both feet severely injured and is cut up about the head and face, while Mike Matthews is suffering from an injured back and feet. The engineer was in such shape that he could not be moved yesterday, but if his condition permits he will be brought to the Keogh-Wright hospital today.

The man was found upon upper Main street by Quarantine Inspector Korth, who, noticing the pox on his face, had him examined by Dr. Mayo and immediately taken to the pesthouse.


