NEW YORK, May 12.—The stock market made some stand against depression today, and early in the day some recovery was effected from yesterday's sharp declines.

The arrival in San Francisco of a consignment of \$2,500,000 worth of immediate cash available for the purchase of gold bars, transferred provisionally to the Treasury, has been a factor in the recovery.

The two-point rise in Amalgamated Copper, the only stock to advance, was due to the general market recovery.

The forecast of the week's currency movement made a less formidable showing than was feared, in view of the enormous movement of the week.
