PROGRESS OF WORK ON THE IMMENSE PLANT OF UTAH LIGHT AND RAILWAY COMPANY

The entire western half of the building is provided with car pits for the accommodation of workmen while working under the cars. There are sixteen of these pits, which are 210 feet long. In addition to these there are four wash pits in the west end of the building, where cars may be taken to be cleaned. These pits are constructed of cement.

The walls of the building are of reinforced concrete, the front of red pressed brick with concrete borders. The roof arches are of steel and the roof covering is mission architecture. The cost of the building with the heating plant will be \$200,000.

One of the features of the plant will be the water tower, 100 feet high, which will hold 50,000 gallons of water, for use in the event of fire. The grounds are to be enclosed by a handsome ornamental iron fence except where there are unsightly material piles, and the ground bordering the sidewalk will be graded and given the appearance of a lawn. Everything about the place will be so constructed to bring out the most artistic effects without sacrificing in any way the use for which it was constructed. Entrances to the plant will be at the east and west ends, so that the system can be operated from both sides at once. Everything about the place will be of the most up-to-date construction. There will be electric lights and steam heat in the offices and club rooms and the appliances for moving cars inside the barns will be of the most modern type. Brickwork construction already has been started. As far as possible the new plant will be used for the storage of cars while the buildings are being constructed, and it is expected that the company will be operating from the plant by next spring.



ROUSING AMERICAN RALLY HELD AT TOOLEE Special to The Tribune. TOOLEE, Oct. 27.—There was an unusually large crowd in attendance at the American party rally held at the town hall this city tonight. From start to finish the meeting was a brilliant success and great enthusiasm was displayed. R. W. Wiley and others spoke, and appropriate music was furnished. Mr. Wiley spoke largely on what the American party has done in Salt Lake City, declaring that if there was but one plank in the American party platform—and that plank was progress—it was entitled to the suffrage of all of the people of Utah. The speaker said that when politics and religion were mixed, it robbed the latter of its spiritualistic force. He gave the "Month" several hard "slams" and declared that no member of the federal gang was fitted to occupy any high civil office.
