GENERAL DIAZ ANNOUNCES HE WILL RESIGN

Scenes and Characters in the Dynamite Drama

... Who Leaves His Position Front of Juarez to March Upon Capital, Highly Elated; Mexican People Overjoyed at Prospect of Peace; News Received with Satisfaction by Officials in Washington.

GLORIOUS CAREER OF THE REBEL JUST HUMILIATED

CITY, May 7.—General Porfirio Diaz issued a manifesto to the people of Mexico declaring his intention to resign the presidency as soon as the revolution is completely suppressed. In this manner the general acceded to the demands of the rebels. General Diaz, who has been in the city since his return from Juarez, is highly elated at the prospect of peace. News received in Washington with satisfaction by officials in the capital.

JOY IN REBEL CAMP.

Madero Praises Diaz for Personal Sacrifice and Patriotism.

EL PASO, Tex., May 7.—When General Madero heard of the dispatch from Mexico City concerning President Diaz's resignation, he immediately gave orders to have troops stop marching. Couriers were sent ahead to halt the advance guard.

STIRRING CAREER OF DIAZ.

Fighter From His Youth Up; Compelled to Yield in Old Age.

Porfirio Diaz was born September 15, 1859, on the anniversary of Mexican independence. His father was a Spaniard and his mother of Indian extraction. His mother at first intended that he should enter the church, but finally yielded to his desires so that he pursued the studies then required for a lawyer's career.

Elected President Eight Times.

Diaz was regularly elected president of Mexico for the first time in 1877. He was succeeded at the end of his term by General Manuel Gonzalez. His crowning achievement in the Gonzalez administration was the abrogation of the law against presidential re-election, and in 1884 he was elected president for the second time. There has been no other president in Mexico since then, and until last summer the opposition to him never attained serious proportions. He was elected president for the eighth time June 5, 1910.

McManigal Despondent.

On the other hand, Ortie McManigal, whose alleged confession is expected to be one of the main props of the prosecution, appears to have lost nearly all of his cheeriness, and assumed some of the moroseness that formerly distinguished his reputed companion, James McNamara. He seemed so despondent today that Jailer Gallagher asked him what was wrong, and McNamara replied: "I'm wondering whether my wife has forgotten me. I have not heard a word from her since I left Chicago, and I am suffering for news from her and the children."

James McNamara Talkative.

James McNamara was even talkative at meal time, when he sat in company with Jailer Gallagher and a guard. Gallagher said he expressed pleasure that Clarence Darrow, the Chicago attorney, was soon coming to assume charge of the defense.

This was the first time that he had any conversation with the jailer. John McNamara sent for law books yesterday and spent part of the day perusing them, thus giving the impression that he intends to use his knowledge as an attorney to aid those who will be charged with combating the state in the struggle for his life and that of his brother.

BOLD GAME PLAYED AT SAN FRANCISCO

Chicago Tourist "Steered" to Hotel by Confidence Man Met on Ferryboat.

HANDCUFFED AND ROBBED

Trick Turned by Bogus Deputy Sheriff, Who Escapes With His Loot.

SAN FRANCISCO, May 6.—William Schumacher, a 25-year-old Chicago tourist, was "steered" to a hotel room here tonight by a confidence man, and soon thereafter locked into it, handcuffed and robbed by another one. The police say the trick is the boldest perpetrated here for some time.

Schumacher arrived here from Portland late today and while crossing to San Francisco from Oakland on a ferry boat was accosted by an elderly stranger, claiming to be a diamond cutter, who voluntarily recommended a "good hotel."

TWO KILLED WHEN AUTO GOES OVER EMBANKMENT

Edmund F. Richardson of Denver and Horace Granfield of Mount Vernon, N. Y., the Victims.

DENVER, May 7.—Edmund F. Richardson, a prominent attorney of this city, who was one of the counsel for the defense in the Meyer-Haywood trial in Idaho four years ago, and Horace Granfield of Mount Vernon, N. Y., a wealthy mining man with large interests in this state, were killed near Louisville Junction, twenty miles north of here, this afternoon when an automobile in which they were riding plunged down an embankment.

IMMENSE REDS FOR ST. LOUIS CATHEDRAL

LONDON, May 7.—There has just been completed at Exeter, famous as a school of ecclesiastical art, an immense reds for Christ Church cathedral at St. Louis. Planned much on the lines of Cardinal Beaufort's high altar screen in Winchester cathedral, the reds is fully thirty-five feet high and is composed entirely of Caen stone. In regard to size and ornate detail it is to be the largest and most important made in this country since the middle ages.

AWAIT ACTION BY THE SENATE

Canadian Parliament to Adjourn for Two Months While Premier Goes to England.

RECIPROCITY PACT IS HELD UP IN MEANTIME

Educational Campaign for the Agreement to Be Prosecuted in Dominion.

OTTAWA, Ont., May 7.—The adjournment of parliament for two months while Sir Wilfrid Laurier and the Canadian parliamentary delegation are in England attending the coronation will mark the beginning of an educational campaign for reciprocity throughout Canada under the direction of the Liberal members of the house. The opponents have planned a similar campaign against ratification.

The government is confident the result will be the creation of so strong a demand for ratification that the Conservatives will not be able to continue their filibuster when parliament resumes, provided the United States senate in the meantime takes favorable action.

Expected to Do Much Good.

In addition to this, the government was informed that the United States senate probably would not vote on the agreement until July, and as it is certain the Canadian opposition will continue its filibuster until Washington has taken final action, Sir Wilfrid probably would be compelled to remain away from the colonial conference and the coronation, the British authorities became much exercised. It is understood personal messages were sent to Sir Wilfrid by King George, Premier Asquith and other British leaders urging him to reconsider since coming to Seattle. His widow and two children reside in St. Paul.

SLASHES HIS THROAT WITH POCKET KNIFE

SEATTLE, Wash., May 7.—W. L. Moran, 45 years old, who came to Seattle from St. Paul two weeks ago, committed suicide in his room in a hotel here today by cutting his throat with a pocket knife. Moran was a former telegraph operator in Yellowstone park. He had been despondent since coming to Seattle. His widow and two children reside in St. Paul.

FREE LIST BILL TO PASS TODAY

House Tariff Tinkers Will Then Turn Their Attention to the Wool Schedule.

SENATE TO SELECT PRESIDENT PRO TEM

WASHINGTON, May 7.—Congress will busy this week with many subjects. Tariff tinkering will have a change of scene, the senate committee on finance taking up the Canadian reciprocity bill with hearings expected to continue throughout the week.

LOGAN DESIGNATED FOR POSTAL SAVINGS BANK

Equipment Will Be Furnished in Time to Permit Deposits by June 1.

WASHINGTON, May 7.—Postmaster General Hitchcock today designated thirty-six additional postoffices as postal savings depositories, which, including those previously selected, will make a total of 129 established since January 1. The work of furnishing the necessary equipment and having the postmasters and their assistants instructed will be hurried to permit deposits June 1. Mr. Hitchcock expects to extend the system as rapidly as possible until he has a postal savings bank in every postoffice in the United States.

TALON JUMPS TO HIS DEATH

George M. Lewis Commits Suicide by Leaping From Commercial Block.

PATROLMEN FIND HIM IN DYING CONDITION

Financial Troubles Are Said to Have Caused His Act.

George M. Lewis, one of the best known tailors in Salt Lake City, committed suicide at 7 o'clock Sunday morning by jumping from a fifth-story window on the west side of the Commercial block. Shortly after taking the fatal leap, Lewis was found in the alley by Patrolmen Burton and Pitt.

Patrolman Burton had seen Lewis and spoken to him in front of the Commercial block just a few minutes preceding. Although fatally injured, Lewis recognized the patrolman and said to him: "George, I am going to die. Give this to my wife. Lewis then reached into his coat pocket and handed a purse to Burton. At the same time the injured man pointed upward toward the window from which he had jumped, but lapsing into unconsciousness without saying anything further. Later the purse was delivered to Mrs. Lewis. It contains \$10.

Talks to Physician.

As soon as possible after Lewis was found in the alley, he was taken to St. Mark's hospital, where Dr. H. B. Sprague attended him. An investigation revealed the fact that Lewis, who was a bachelor and his spine dislocated, in addition to internal injuries.

Leaves Home Early.

Sunday morning Lewis arose early and left the home at No. 2 Brunswick court, about 6 o'clock, telling his wife that he was going to the sanitarium for a bath. Instead of going to the sanitarium, he went directly to the Commercial block, ascended to the fifth floor and leaped to his death.
