

PEARY NEARING HOME

Will Reach New York by Train Early Next Week.

SHIP IS LEAKING SOMEWHAT

Slow Progress Made by the Roosevelt, but Commander Will Probably Leave Vessel at Sydney and Accompany His Wife, Who Is Awaiting His Arrival at That Port.

Sydney, N. S., Nov. 22.—The arctic steamer Roosevelt, with all on board, reached Port au Basques at 11 o'clock this morning. As it is intended to push her at all speed, and will sail for Sydney at the earliest moment. She is leaking to some extent and weak, and cannot stand rough weather. The coaling facilities at Port au Basques are not good, and she had to be hand-landed.

Commander Peary, contrary to reports circulated here, will not enter the Roosevelt at North Sydney. It is his intention to get her to New York in a condition as nearly approaching her present shape as possible for exhibition purposes. To do this he must repair her temporarily, and he may have to ship new men.

Awails Husband at Sydney. Mrs. Peary has not left her room at the hotel here, and so far as she can decide now, will await her husband at this port. Peary and wife and most of the officers, it is expected, will go to New York by train from this place, but under the conditions now existing they cannot hope to reach the United States before next week, as there are no Sunday trains. The Roosevelt is expected to reach New York on Monday, and the crew has evidently been warned against giving out any information.

The Roosevelt reached Port au Basques owing to the storm-post having been broken by contact with the ice, and the jury rudder rigged was only workable in smooth water.

Good Time Made by the Ship. Made good time up through Belle Isle Straits and along the Newfoundland coast.
