PENSION LIST GROWS

Clerks are Overworked Following Application.

Nearly 200,000 applications for pensions have been received at the Pension Office since the age act was passed by Congress in February granting government allowances to any soldier who served ninety days or more in the military service of the country during the civil war, or sixty days in the war with Mexico, and who has reached the age of sixty-two years. It is provided that applicants must have an honorable discharge.

Result of McComber Bill.

The applications are from all parts of the country. Many of the veterans range in age from eighty-five to ninety years, and heretofore have not been receiving any benefits from the government owing to no disabilities received in engagements in which they took part. Day after day hundreds of papers continue to pile up upon the Pension Office employes, and the passage of the McComber bill has been the cause of all kinds of work at the department. After being approved, the pension begins with the date of filing.

Provides for All Veterans.

The act provides that any veteran who has reached the age of sixty-two years is entitled to \$12 a month. Those who are seventy years old are entitled to \$15 a month, and the old soldiers who have passed the seventy-five-year mark or over are to be allowed \$20 a month. This bill is for the benefit of all those veterans who have not been receiving pensions heretofore. The new law will be the cause of the withdrawal of hundreds of applicants who have had their papers on file for months, even years. New papers will have to be made out by the applicant in each case and acted upon accordingly at the department headquarters.

Pension List Long One.

Although, including the survivors of the civil war, the government is now paying pensions to 575,243 persons. This number includes the veterans of all wars of the United States for which provisions have been made for pensions. Many widows and children of old soldiers are also on the roll. All told, 652,638 veterans of the civil war are now pensioners on the list of the government.

After being approved, the pension begins with the date of filing.

Provides for All Veterans.

The act provides that any veteran who has reached the age of sixty-two years is entitled to \$12 a month. Those who are seventy years old are entitled to \$15 a month, and the old soldiers who have passed the seventy-five-year mark or over are to be allowed \$20 a month. This bill is for the benefit of all those veterans who have not been receiving pensions heretofore. The new law will be the cause of the withdrawal of hundreds of applicants who have had their papers on file for months, even years. New papers will have to be made out by the applicant in each case and acted upon accordingly at the department headquarters.

Pension List Long One.

Although, including the survivors of the civil war, the government is now paying pensions to 575,243 persons. This number includes the veterans of all wars of the United States for which provisions have been made for pensions. Many widows and children of old soldiers are also on the roll. All told, 652,638 veterans of the civil war are now pensioners on the list of the government.

Held for Stealing Turkeys.

On the charge of having stolen a number of turkeys from the warehouse of the Golden-States Company, commission merchants, 32 Louisiana avenue northwest, a few days before Christmas, Hurley Brooks and Richard Newton, both colored, were arrested in Philadelphia yesterday by Detective Cornwell, of the Central bureau, assisted by the police of that city.
