

HELD TO BE FORGERY Changed Telegram Case to Go Before Grand Jury.

TELEGRAPHER IS ACCUSED

Capitol Operator Alleged by Assistant District Attorney to Have Inserted Word in Message Which Resulted in Defeat of New York Racing Bill—Fassett a Witness.

The facts in connection with the change in the wording of the telegram to Senator Owen Cassidy, of New York, which resulted in the latter voting against the anti-racing bill in New York and thereby causing its defeat, will be presented to the grand jury.

Assistant District Attorney Harvey Given, who has been conducting an investigation, yesterday made a formal report to District Attorney Baker, in which he states that the evidence collected by him, in his opinion, constitutes the crime of forgery.

Mr. Given's Report.

Mr. Given's report to District Attorney Baker is as follows: "In obedience to your request I have to report the result of my investigation of the complaint made to this office by Hon. J. Sloan Fassett, that a telegram sent by him on the 8th day of April, 1908, to Hon. Owen Cassidy, Albany, N. Y., suggesting to him (Cassidy) how to vote on the race track bill, had been altered before the signature of New York, had been falsified.

Case One of Forgery.

"In my opinion, the evidence in the case constitutes the crime of forgery, as provided for by section 543 of the code of the District of Columbia, and it is hereby submitted to you for your consideration.
