COLLIER DENIED BAIL. Justice Gould Refuses to Grant Petition of Indicted Policeman. A motion for the release on bail of John W. Collier, indicted on charge of murder, first degree, for the shooting of Capt. William H. Mathewson, March 5 last, in the Fifth precinct station, was dismissed yesterday by Justice Gould of the District Supreme Court. The action of the court was taken on the ground that to set the prisoner at liberty would be a constructive opinion that he is not guilty of first degree murder. Collier's last resort is now gone, and he will have to stay in jail until his case is called at the fall term of the court. The motion was made by Attorney Henry F. Woodard, representing the former policeman. Last week counsel argued a similar motion before Justice Wright, who dismissed it without prejudice so that it might be taken up with another judge. Last Friday Collier filed an affidavit in which he declared he fired the fatal shot in self defense, thinking his own life was in danger from his captain.

HENS WILL BE BANISHED. New Regulation Affecting Poultry Keepers Soon in Force. The new "fowl regulation" will go into effect in a few days, according to instructions issued to the police yesterday. As a result, a good many poultry keepers in the crowded sections of the city will have to part with their chickens. The law provides that no fowls or pigeons shall be kept in any square or block having 75 per cent of its lots improved, without a permit from the health officer, nor shall they be kept within 25 feet of a house or any other structure used for habitation. Outside of the fire limits this 25-foot provision is raised to 15 feet. New Service to Nashville, Tenn. Effective August 8, Southern Ry. will inaugurate through drawing-room sleeping car service between Washington and Nashville on trains 25 and 26. Will Attend Convention. The delegates from Columbia Lodge of Elks, negro, have completed their arrangements and will leave Washington this morning to attend the annual convention, which meets at Detroit next week. Much interest is manifested in this season, as the two factions that have been separated for three years will be reorganized under one head. The delegates are O. D. Morris, chairman; J. H. Haskins, H. W. Hunter, B. L. Gaskins, and J. W. Patterson.

SLAYER OF NEGRO QUICKLY CAPTURED

Detective Baur Keeps Promise to Get Fugitive.

JOHN TURNER CUT WITH RAZOR

Dies Before Hospital Surgeons Are Able to Get Him on Operating Table—Assailant Says He Killed Turner for Intruding on His Home. Negro Was Looking for Trouble.

Within less than twenty minutes after he had been assigned to the case, Detective Frank Baur, of the Central office force, arrested Eddie Hughes, twenty-two years old, a negro who had three-quarters of an hour previously killed John Turner, twenty-five years old, another negro, at his home, 818 G street southwest.

The murder occurred at 5:30 o'clock yesterday afternoon. Ten minutes later the matter had been reported to Inspector Boardman, in charge of detective headquarters. At the time the report reached headquarters there were a number of detectives in the office, all of whom were detailed by Inspector Boardman to go out and hunt for the negro, who was reported as heading for the river.

After the detectives had left the office and started the search for Hughes with the reserves of the Fourth police precinct, Detective Baur entered detective headquarters. Inspector Boardman told him of the murder and remarked:

Ordered to Make Arrest. "Baur, I wish you would go out and arrest this negro."

Within twenty minutes Baur reported he had Hughes in custody and was on his way to the Fourth precinct station with him.

Baur said he picked Hughes up on the brief and hurried description given him in a barroom at the corner of Eighth and G streets southwest, within two doors of the house where he killed Turner.

To Detective Baur, Hughes said: "Yes, I cut Turner with my razor. He came into my yard to beat my wife, and when I told him to get out he started a 'rough-house,' and attempted to strike my wife. I jumped between her and Turner, pulled my razor, and cut him across the body and once on the head. I was defending my wife from his assault, and he had no business in my room. He rooms in the same house, and has always been looking for trouble and seemed to hold a spite at me and my wife."

After Hughes had cut Turner and the wounded man had fallen to the floor, Hughes left the building and disappeared in the direction of the Potomac River.

Called an Ambulance. Roomers in the house, learning of the cutting of Turner, sent in a hurry call to Emergency Hospital, and the wounded man was taken to that institution, but he died before he could be placed on the operating table. The wound under his right arm was long and deep, reaching the vital parts of the body. He died from loss of blood and internal injuries.

Asked to explain how it was Hughes was found in a barroom two doors from where the cutting occurred, after making his escape in the direction of the river, Detective Baur said Hughes had doubled back on his trail, undoubtedly, to see his wife.


