

# DANIELS WARNS AGAINST DRINK

### Secretary of the Navy Praises Secretary Bryan's Grape Juice Diplomacy.

## TALKS TO SUNDAYSCHOOL

### "Men Who Use Liquor Are Not Capable of Holding Office," Says Speaker.

Statestmen who partake of the cup that cheers were denounced and Bryan's "grape juice" diplomacy was praised by Secretary of the Navy Daniels in three addresses delivered before hundreds of Washington Sunday school children and their elders in Mount Vernon Place Methodist Church and McKendree Methodist Church yesterday afternoon.

The Secretary of the Navy was the principal speaker at the temperance rally of the Protestant Sunday schools, which was held under the joint auspices of the Sunday School Association and the local branch of the W. C. T. U.

While only two meetings had been planned—one in Mount Vernon Church and the other in McKendree Church—it was necessary to hold an overflow meeting in the lecture room of McKendree Church, so enormous was the crowd, which was practically the same at all three meetings.

"Men holding public office should be examples to other men and to the boys of our country," he declared, and "men who drink are not capable of holding public office. While in years gone by drink was scoffed and laughed at by public men, the manner in which it is now looked upon has changed. People do not want men in public office who get intoxicated. And public men realize that it is not proper for them to indulge in drink, and they will vigorously protest against the intemperance that they drink to excess."

This morning I read in the papers of how former President Roosevelt, surrounded by prominent men, is hurrying out to Michigan to enter the courts tomorrow morning for the purpose of fighting a libel suit against an editor who printed a statement to the effect that President Roosevelt drank to excess.

Former View of Drink. "In years gone by this view of drink was not taken. Daniel Webster once became so intoxicated before making a speech that the people laughed at him. And when a woman went to President Lincoln with the protest that one of his generals drank too much, that great President asked, 'What brand of whisky does he drink?' I want to give it to other generals so that they, too, can win battles."

# TURKS' OUTLOOK NOT BRIGHT ONE

### Elder Porter of Seventh-Day Adventists Predicts Disso-lution of Dominion.

## TEXT FROM THE BIBLE

### "Armageddon in Prophecy" Was Title of Sermon Given Before 4,000 Persons.

"The Turk will, before long, be driven from Europe and will place his temporary capital in Jerusalem, and shortly thereafter the Ottoman dominion in Asia will come to an end. This will constitute a sign that the world's Armageddon is about to break in such a way as the history of the past presents no parallel," said Elder R. C. Porter, of Cape Town, South Africa, president of the South African Union Conference of Seventh-Day Adventists yesterday afternoon, in a forcible address on "Armageddon in Prophecy," at the world conference of Seventh-Day Adventists at Takoma Park, in a special preaching service at which there were about 4,000 persons.

"In connection with the prophecy of the driving out of the Turk, the Prophet Joel says: 'Let the heathen be awake and enter into the Valley of Jehoshaphat, to this last-day battle. The heathen shall then have to be reckoned with in this Armageddon battle of the last days. They must first 'awake' and 'prepare for war.'"

"The Armageddon battle will doubtless be a religious war. The different religious bodies of the world are becoming very jealous for the triumph of their religious creeds. The talk of 'holy war' is not confined to Mohammedans. It may be traced also to Catholicism, Protestantism, and Buddhism."
