AUTO DEALERS HOLD HARMONIOUS MEETING

Representatives of Many Makes of Cars Pledge Their Support to Unite "Trade."

A new epoch in the automobile history of Washington was written last night at a meeting of the Washington Automobile Dealers' Association at the Sterling Hotel.

More than 100 men identified with the automobile trade and representing twenty-three different makes of cars, a number of tire manufacturers and accessory houses were present, and pledged their support toward uniting the "trade" into a harmonious organization with cooperation rather than competition as its watchword.

This feeling of a greater association was voiced in the brief words of the numerous members of the organization who were called upon to respond to the toasts. All of them urged closer relationship between the automobile dealers of Washington and pledged their support.

Preliminary reports of those in charge of the arrangements for the 1914 automobile show, during the week of January 18, assure the success of the undertaking.

Announcement was made that more than three-fifths of the floor space already had been secured, and a number of dealers had agreed to enter the show declared their intention of doing so.

A number of others who stated that factory conditions prevented them from doing so offered their assistance to make it a success.

W. D. Arriens, of the Proby Company, acted as toastmaster, and the inauguration of the occasion was evidenced in the remarks he made in introducing the speakers. Every one was unanimous in declaring that the meeting last night was the largest in attendance and the most enthusiastic in the history of the organization.

AVIATION PROGRESS SHOWN.

Capt. W. I. Chambers Submits Plans for Improved Hydro-Aeroplane. A plan for the development of aviation in connection with the navy, including the use of dirigible balloons, has been prepared by Capt. Washington I. Chambers, retired, who is in charge of aviation in the navy.

The work for the last year, Capt. Chambers reports, has centered largely upon the development of the "flying boat" or hydro-aeroplane, which had its origin in the United States.

Researches have been conducted and experiments made at the model basin for hull testing, and investigations also have been made in co-operation with the Langley aerodynamic laboratory, temporarily established by the Smithsonian Institution.

A feature of the navy aviation in the last year has been the instruction given officers and men of the fleet during the winter exercises at Guantanamo, Cuba. Two hundred and twenty officers have taken instruction or observation flights, and 300 flights have been given to petty officers and enlisted men.

STEEL PLANT NOT TO CLOSE.

Gary Furnaces Will Not Shut Down, Says Corporation Head. New York, Nov. 24.—Persistent rumors and dispatches from the West that United States Steel Corporation contemplated shutting down the Gary plant were denied today by Judge E. H. Gary, chairman of the corporation.

Judge Gary said: "We have no plan for closing any of our plants. Individual mills or furnaces may be closed temporarily from time to time, if business conditions compel, but any such question will be considered and decided if and when it arises."

CITIZENS ELECT OFFICERS.

North Capitol and Eckington Association Makes Report. Dr. Edgar C. Thompson and A. "MERCURY TWINS" IMPROVE.

Turner Boy Out of Danger and Clark Child's Chances Good. Given up to die from bichloride of mercury poisoning, little Walter F. Turner, the seventeen month old son of Joseph Turner, bookkeeper, of 63 Tenth street northeast, has won his fight for life at Casualty Hospital.

Taken to the hospital eight days ago after chewing up a mercury tablet, the boy has shown steady improvement. His parents expect to have their baby boy with them Thanksgiving Day.

What of the children's hospital another little boy, the second of the "mercury twins," William Clark, of 707 C street northeast, is putting up a good fight. His chances for recovery are good. The Clark boy is the same age of the Turner boy. He was taken to Casualty Hospital Sunday afternoon, and later transferred to Children's. Dr. S. Doyce Poole, family physician, diagnosed his illness as that of mercury poisoning.

Jewel Thieves Sentenced.

London, Nov. 24.—Sentence was pronounced at the Old Bailey today on four prisoners charged with stealing and receiving the pearl necklace, valued at \$50,000, which disappeared during transit by registered mail from Paris to London July 25, but was afterwards found lying on a sidewalk in London with only one or two pearls missing.

Gems Given to Kaiser.
