**WALTER REED BOYS EDITORS**

Will Publish "The Comeback" for Benefit of Wounded Heroes.

Wounded war heroes at the Walter Reed Hospital here are going to be given a royal chance to make their livelihood in journalistic endeavors beginning December 4 when they will launch a new publication to be nationally circulated as "The Walter Reed Comeback."

Publication of this paper by the crippled men in khaki here is planned by the Surgeon-General's Office, in co-operation of other branches of the War Department, as the first of a chain of newspapers to be established at each of the twenty odd big base hospitals to which wounded American soldiers in France are now being brought.

Although the dominant theme of these papers is that they will interest and entertain the wounded soldiers, it is felt that the little string of community newspapers may become the nucleus of practical schools for those afflicted men who hope to find places in the newspaper game either as linotypers, special writers or cartoonists.

The soldiers themselves are planning to assemble and edit their news, operate their own machines and make up the paper and print it on their own press. It is said that it will be a compromise between a small town country weekly and a peppy college paper.

A special effort is being made to get out an exceedingly interesting first edition at the Walter Reed Hospital to which some of the most famous authors in America have contributed.

**HONOR SCROLL FOR WAR WORK**

Honorable Discharge Testimonial Planned by Ordnance Bureau.

Each woman war worker in the Ordnance Department when she is released from the service is to receive a document—an honorable discharge—similar to a soldier's or sailor's, if plans now under consideration are carried out.

With the grim at the office, and living conditions here to contend with, the civilian worker in Washington has had very little of the glory and magnificence of war to lighten the load at home.

Now the Ordnance Department, it is understood, considers giving to each civilian worker, on separation from the service, an "honorable discharge" stating that the employment has done faithful work. It is thought that the signature of Maj. Gen. Clarence C. Williams, Chief of Ordnance, will be one feature of the document, and that the signature of the head of the division in which the individual was employed will also be appended.

Many war workers are anxious to possess such a document as a keepsake, to aid in obtaining future positions.

**DANIELS REDUCES NAVY EXPENDITURES**

44 Percentum Lopped Off Original Estimates for Fiscal Year.

Reductions in naval proposed expenditures aggregating \$1,180,215,572, are itemized in a memorandum sent yesterday by Secretary of the Navy Daniels to Mr. McAdoo, Secretary of the Treasury.

The original estimates for the fiscal year ending June 30, 1920, for the navy, were \$2,644,307,046.05. The navy had therefore lopped off over 44 per cent of the sum.

The items of reduction are: Pay, miscellaneous, \$5,012,000; aviation, \$132,770,700; Bureau of Navigation, \$4,028,663; Bureau of Ordnance, \$133,412,716; yards and docks and public works, \$9,468,000; pay of the navy, \$275,324,285; Bureau of Supplies and Accounts, \$24,863,215; Bureau of Construction and Repair, \$37,500,000; Marine Corps, \$32,702,954; Naval Emergency Fund, \$113,145,000.

In the memorandum Mr. Daniels says: "I will advise you before the week-end of the manner in which these reductions affect the figures I have supplied you of probable treasury withdrawals during the ensuing fiscal year."

**COAL RESERVE BAN LIFTED.**

Users of Bituminous in Pittsburgh District May Lay in Supply.

Arrangements have just been completed, at a conference held in Pittsburgh, for the storing by the industries and domestic consumers of that district of their winter supply of bituminous coal, the United States Fuel Administration announced yesterday.

This is in accordance with schedule for bituminous distribution. While coal was being shipped to lake points, the supplies of domestic consumers and industrial plants in the Pittsburgh district were limited to actual necessities. Now they can store their winter supplies.

**Hun Damage to Mines Halts Coal Production**

Damage done by the Germans to the coal mines at Lens, France, is so great that production cannot be resumed for periods ranging from eight months to three years, in the opinion of members of the special commission of the United States Fuel Administration as expressed in a cablegram received yesterday by Harry A. Garfield, United States Fuel Administrator.

The message, which was sent from Paris after a three-days' inspection of mines in the Lens region, states that the damage varies in degree; that production cannot be resumed for periods ranging from eight months to three years, and that plans for reconstruction are still under advisement.

**FAVORS BOOST IN POLICE PAY**

Pullman Recommends Minimum Salary of \$5 Per Day for City's Guardians.

Washington policemen are to receive a minimum of \$5 per day if the recommendations of Maj. Pullman in his report for the fiscal year ended June 30 are adopted.

Maj. Pullman in his report points out the increased responsibilities devolving upon the Metropolitan Police Force, due to the great increase in population caused by the influx of war workers. The immense increase in the cost of living, with no consequent raise in salaries, is given by Maj. Pullman as the principal reason for the depletion of the ranks of the department to such an extent that limited service men in the army had to be called upon for police duty.

The time has come when trained, conscientious patrolmen of the highest grade should be paid a salary of at least \$5 per day. Although this is far more than is paid in any American city at the present time, it is believed that within the next three years scores of cities will be paying this much or more to the men who are responsible for the protection of the people and property of our country.

Maj. Pullman also recommends that an appropriation be made which would enable the government to pay the cost of uniforms. According to the report, the cost of uniforms has just been doubled in the last two years.

The Sheppard prohibition bill is declared by Maj. Pullman to be the principal factor which has contributed to the lack of serious disorder or riots of any kind during the entire period of the great war. According to the report, the percentage of drunkenness under license during the year covered by the report in homicide cases was 100 per cent. Every single murder occurred during the year was cleared up and the parties charged with the crime arrested. During the year there were twenty-seven murders being the second largest in the history of the city.

"The large number of crimes committed during the year by irresponsible people, particularly by bootleggers and poolroom hangers, on carrying dangerous weapons, emphasizes the need for increased police authority to regulate more strictly the sale of firearms of all kinds," says the report.

**MILK PASTEURIZATION URGED FOR ALL D. C.**

Control Through Central Plant Suggested by Tuberculosis Fighters.

A plea for general pasteurization of the District's milk supply under municipal supervision was embodied in a resolution adopted last night at the tenth annual meeting of the Association for the Prevention of Tuberculosis.

Discussion following a paper on "Recent Developments in Infant-Feeding," by Emile Berliner, vice president of the association, led to the adoption of the resolution. A central plant owned and controlled by the District of Columbia was recommended.

The meeting was held at the Georgetown University Medical School, 920 H street northwest.

The following officers were elected: President, Emile Berliner, vice president, Dr. Harvey W. Wiley, secretary, Frank P. Reese, treasurer, Walter S. Ufford.

**3 Colored Men, Charged With Robbery, Acquitted**

Albert Collins, John E. Crocker and Clarence Sutton, colored, were acquitted of the charge of robbery, yesterday. The jury of Criminal Court No. 1, after hearing the case for almost all day, consulted less than ten minutes before delivering the verdict of not guilty.

**POLICE SEEK MISSING GIRL**

Pretty Frances Vaughan Leaves Home to Seek Future Alone.

When pretty 15-year-old Frances Olive Vaughan locked the door of her room in her home at 906 I street northwest, Friday morning, she did so with the intention of also locking behind her all childhood memories.

This is the conclusion of her mother, Mrs. J. M. Brownell and her stepfather, after discovering numerous matters which her daughter had surreptitiously attended to during the past six weeks.

While her mother never suspected that Frances, who was a student at the Central High School, intended to leave, she is now confronted with evidence which undoubtedly proves her daughter had been laying elaborate plans in connection with a premeditated disappearance.

Police, detectives and the Department of Justice have already prepared circulars bearing the missing student's photograph and are scouring neighboring cities where her mother believes she may have gone to get employment as a telephone operator, in which capacity she is experienced.

After unlocking the door of her daughter's room Mrs. Brownell found she had taken all pictures of herself from their frames, as well as stripped her closet of a well-filled wardrobe. She asked her mother for money just before she left her home, presumably for the Central High School.

Little Miss Vaughan also took with her her jewelry, including a diamond ring and about \$10 in cash.

Her teachers at the high school can offer no clue to her disappearance. They declare she had been a girl who was studious, yet she had never mingled much with the other students.

Her pleasures were of the quieter sort and it is not believed by her home folks that she had movie aspirations, although she often visited nearby theaters.

Friends of the girl declare she is decidedly attractive, possessing a quantity of gold brown hair, hazel eyes and a delicate pink and white complexion.

All will be forgotten and forgiven, her mother stated, if her daughter will return. Every hope is held by the family that she will return in time to share the family dinner on Thanksgiving.

Detailed description of the missing girl on the police bulletin gives her height as five feet three inches, weight, 110 pounds. When last seen she wore a green Tam-o-Shanter cap, a green sweater, a dark blue suit and a black and white checked coat.


