

## WOMEN WILL AID MEMORIAL DRIVE

Pledge Support in Campaign For \$10,000,000 D. C. Building.

Prominent Washington women yesterday pledged their aid to the \$10,000,000 National Memorial Building campaign, which opens Monday, and completed plans for co-operation in the drive. This action was taken at a meeting in the home of Mrs. Henry F. Dimock on 10th street.

Among the speakers were Mrs. Imock, Madame Grouitch, wife of the Minister of the Serbs, Croats and Slovenes, and Mrs. Martin Storer. Mrs. Dimock described the building, plans for which have been approved by the National Society of Fine Arts, and which is to be erected on land granted by Congress to the George Washington Memorial Association.

"Let us all work for the boys of 1917 and do all we can for them," she said. "This building is essentially for them—for those who were wounded, and above all, to the memory of those who made the supreme sacrifice in the world war."

Madame Grouitch told of the great interest in the National Victory Memorial Building, and said the great ambition of her life is to see the structure erected in Washington—the most beautiful war monument in the world.

## DIVORCES DUKE AND \$5 A MINUTE

Duchess of Westminster Gets Freedom on Grounds Of Desertion.

London, June 12.—The Duchess of Westminster today was granted a divorce from the Duke of Westminster on charges of desertion. The biggest society crush in years, crowded the King's Bench Court to hear the testimony.

The Duke was not represented by counsel. He entered a denial. Lord Coleridge, judge of the divorce division, presided. The Duchess occupied a quarter of an hour in presenting her story. She said their early married life was happy, but that in 1909 they became estranged.

"After that the Duke paid no attention to me," she said. "He stayed out all night. I begged him to come back for the sake of the children and keep up appearances, but he refused."

"At 11:30 every night a motor took him away. He would return about 7 o'clock in the morning. He agreed to allow me £1,000 (\$35,000) a year and free use of his yacht." In June, 1917, the Duchess said, she and private detectives watched the Duke and saw him rent a house in Brighton, in his own name. Shortly after midnight, she said, he met a woman, who went to the Duke's suite in a hotel and did not leave until morning.

The Duke's name has frequently been coupled with those of well-known actresses and other women. The Duke is one of the wealthiest men in Great Britain, his income being estimated at \$5 a minute. He was an officer during the war, and the Duchess a nurse.
