**FIGHTS RAISES OF RAIL RATES**

**Nevadan Argues Before Commission Against Increase in West.**

An increase in railroad freight rates at the present time would mean only another round of the "vicious circle," said J. F. Shaughnessy, chairman of the Nevada railroad commission, testifying yesterday before the Interstate Commerce Commission. In opposing the application of the Western railroads for a 24 per cent advance, Shaughnessy said the increase would be reflected "all along the line" and the roads soon would find themselves in relatively the same earning and credit condition they are now.

"The increase should be denied," he told the commission, "except in so far as the commission may find it necessary to increase rates in certain sections of the United States by the process of equalization."

"The United States Steel Corporation recently has taken a stand and prevented any further increase in the price of iron and steel, and we think the same procedure should be taken by some big leader at the head of the railroad financial world."

The railroads are here asking for a \$1,000,000,000 increase in rates and have also given notice that still another \$1,000,000,000 per annum will be necessary following the granting of wage increases by the Railroad Labor Board.

Shaughnessy vigorously attacked the bookkeeping for estimating the value of the railroads and made a plea for efficiency in operation which he asserted was sadly lacking.

"During the war," he said, "the Council of National Defense found freight cars were in the hands of the shippers 37 per cent of the time and that the balance, or 63 per cent, of the time that they were in the possession of the carriers, they were moving only 11 per cent of the time. Taking into consideration the congestion conditions existing today it is safe to say that there has been no improvement."

**Virginia Apple Growers Pool Barrel Orders**

Winchester, Va., June 12.—Commercial apple growers of the Winchester district have agreed to pool their orders for barrels during the coming season in the hope of having deliveries guaranteed, but it is understood there is to be no reduction in price on account of the pool.

The crop promises to be greatly in excess of that of last year, and with barrels selling at 11 apiece the growers feel it will be necessary to throw away a portion of the cost on the buyer.

**TRUCKS START 'ACROSS' TODAY**

**All-Metal Monoplane Carries Five Passengers in Race to N. Y.**

**Army's Cross-Continent Tour Will Get Under Way at 9 a. m.**

New York, June 12.—A thrilling race between two all metal monoplane from Washington to Central Park, L. I., today was won by Col. W. K. Wilson, of the General Staff of the army, defeating Col. W. E. Gilmore, chief of the Supply Group, United States Air Service. The winner covered the 248 miles in 145 minutes, six minutes ahead of the second machine, chief of operations. Col. Wilson carried five army officers and one woman in the enclosed cabin of his machine, and Col. Gilmore had five officers as passengers.

The flyers used the new Larsen monoplane, with internally braced wings. Col. Wilson carried five army officers and one woman in the enclosed cabin of his machine, and Col. Gilmore had five officers as passengers.

At the conclusion of the race the winner said: "I wrote three letters on my way up. The writing is legible and firmer than if I had done it on a Pullman car. I think this type of airplane will serve a very useful purpose in the army. The trip today was made in excellent time, despite three storms. Just before the start at Washington, Col. Gilmore said the Assistant Secretary of War, Benedict Crowell; Maj. Gen. Charles T. Menoher, director of the air service, and Brig. Gen. William Mitchell, chief of operations, took a short flight in one of the machines.

**CAN'T MAIL KIDDIES— DANGEROUS ANIMALS**

Children are not "harmless animals" and because of their potential for danger they may not be mailed as parcel post. This decision was reached yesterday by the Postoffice Department in reply to a request for an official ruling from the Washington city postoffice.

But if you want to ship your goldfish or soft shell crabs or any similar little pet that requires no feeding while en route and cannot attack or injure the mail cars of clerks, why go ahead.

"By no stretch of imagination or language," says the ruling, "can children be classified as harmless, live animals that do not require food or water."

The publicity which attended the request for a ruling after two applications had been made in a week brought another mother to the post-office yesterday who wished to send her three-year-old child for a visit to the country with a postage stamp ticket.

Paris, June 12.—Possibly with the idea of safeguarding the morals of thousands of American tourists hereabout the French Senate on Thursday rose in wrath against the licentiousness of French music halls and their billboard announcements. It is the first time within memory there has been such unanimity of opinion that a certain portion of the Paris stage has reached the "limit" as regards its offerings. Specific revues now playing of which the senators complained are "All of Love," "Sister Seeks Lover," "Fruits of Voluptuousness" and "Three Perverse Nights."

A "dance of the seven veils" recently performed at the opera where, after abandoning six veils, the dancer had nothing remaining but a very gauzy seventh, was also under discussion and it was further pointed out that a director, who has made a specialty of producing scandals, recently was made an officer of the Legion of Honor.

Fort Jay, Baker said, is in every sense as much a disciplinary barracks as Leavenworth and it lies entirely within the discretion of the commanding general under whose jurisdiction a court martial is held where a prisoner shall be confined.
