MINISTER BLOUNT DEPARTS.

He Goes to Georgia to Look After Personal Affairs.

Thought to Favor a Protectorate for Hawaii—Thanked by Secretary.

Graham—He Will Resign.

There being no further necessity for Minister Blount's presence in Washington until the President returns to the capital, he has taken advantage of the intervening time to visit his home in Georgia, in order to look after certain private matters said to require his immediate personal attention.

He has concluded his official business with the State Department for the present and will return to Washington until the President's return to the capital.

Secretary Gresham paid him a visit at the Shoreham last evening and took occasion to congratulate him on the thorough manner in which he had performed his duty.

While it was impossible to get Mr. Blount's views on the subject of the protectorate for Hawaii, the impression is strong that he favors the establishment of a protectorate over the Hawaiian Islands in preference to their annexation to the United States under any conditions.

The text of the Johnson bill is as follows: Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That any holder of bonds of the United States may, after the passage of this act, deposit such bonds at the treasury of the United States, and receive therefor their face value in treasury notes of the United States, which shall be valid and receivable for all purposes as if they were cash.

Dr. DeWitt is held as a special deposit, and during the time they are so held will be held in trust for the party depositing them on the payment of their face value in cash.

While the bill is in the hands of the committee, it is understood that Secretary Gresham has been informed that the bill is to be reported to the House on the 27th inst.
