The Law Against Assemblies on the Capitol Steps.

There is one circumstance which may interfere with the main feature of Gen. Coxy's announced program at Washington. It has been stated that the object of his bringing his army here is to assemble on the steps of the Capitol on the 1st of May.

REPRIEVE OF PRENDERGAST.

Stay of Proceedings Granted to Inquire Again into His Sanity. Shortly before midnight at Chicago last night, after a hearing that had lasted nearly eight hours, in a lengthy and somewhat opinion, decided that both under the common law and the revised statutes the court had inherent power to prolong the date of execution of Prendergast, Carter Harrison's murderer, who was to have been hanged today.

It was due to the criminal jurisprudence of the state that this matter should have a calm, deliberate, clear and full consideration. The law is not to be applied in a case of this kind.

When the judge announced his decision a deputation of the many who had gathered about the court, and who were waiting for the execution of Prendergast, were turned out to another place with a view of satisfaction. He was quickly ushered out of the court.

Acting Gov. Gill and the judges of the United States circuit court refused to interfere with the law. The law is not to be applied in a case of this kind.
