Since the interference of the B. and O. officials with the attempted connection of the Tenleytown Company's tracks with their Water street elevator barge and dock branch, as reported in The Star last week, nothing new has developed, further than the tearing up of a part of the roadway north of the Water street track, preparatory, apparently, to the laying of an independent track to the wharves, the goal of the Tenleytown Company. The only authority that has been given the Tenleytown people for their operations, as far as the record goes, is that contained in the following morning edition of The Star: "The Georgetown and Tenleytown Railroad Company has permission to lay a single track from the end of their present track on 32d street to the Potomac river along or near 32d street. Provided that nothing in this permit shall be construed as to authorize the tearing up of the roadway north of the Water street track." The sand wharf that the company desires to reach is located at the foot of 32d street.

INTRUDERS TO BE EJECTED FORCIBLY
