

MRS. WALLER ARRIVES

Mrs. Waller, the wife of ex-Consul Waller of Madagascar, accompanied by her three children, arrived in Washington today, and is the guest of her son, Mr. Simms' house, 316 A street northeast.

She is to be interviewed by the French government. Mr. Waller was tried by court-martial by the French authorities in Madagascar on the charge of giving clandestine information to the Hovas, with whom the French were at war, and was sentenced to twenty years' imprisonment upon conviction.
