REMAINS FOUND IN BARREL CHICAGO POLICE HAVE ANOTHER MURDER MYSTERY.

The Victim's Feet Were Tied Together and the Throat Had Been Cut.

CHICAGO, November 5.—The body of a man about thirty years of age, whose head had been almost cut off, was discovered in a flour barrel on a strip of prairie near Rice street and Western avenue early today.

Two laborers discovered the body. They immediately notified the police, who, after investigation, advanced the theory that the man had been murdered last night.

The victim is believed to be Antonio Napoli, who, with twenty-five other Italian laborers, reached Chicago last night from Iowa Center, Iowa. Napoli cannot be found.

The place where the barrel was found has been used for years as a dumping ground. It was not until the night of the murder that the barrel was used for this purpose.
