NEW SUPREME JUDGE

President Appoints Oliver Wendell Holmes.

SUCCEEDS JUDGE GRAY

LATTER RETIRES ON ACCOUNT OF ILL HEALTH.

Has Had Two Strokes of Apoplexy Within the Past Few Months.

A dispatch from Oyster Bay, N. Y., last night says: President Roosevelt late this afternoon announced that he had appointed Oliver Wendell Holmes, chief justice of the supreme court of Massachusetts, to be an associate justice of the United States Supreme Court, vice Mr. Justice Gray, retired.

The retirement of Justice Gray was due to ill health. Several months ago he suffered a stroke of apoplexy, which some time later was followed by another. He has not appeared on the bench since he was stricken the first time. His advanced age—seventy-four—told against his recovery with serious force. Realizing that he probably would never be able again to assume the place which he so long had filled with distinguished ability and honor, he decided a short time ago to inform the President of his intention to retire.

Appointed by President Arthur. He was appointed an associate justice by President Arthur on December 10, 1881, his service extending, therefore, through a period of nearly twenty-one years. Judge Holmes, whom the President has selected as Mr. Justice Gray's successor, is one of the most distinguished lawyers and jurists of Massachusetts. His career on the bench, particularly as chief justice of the Massachusetts supreme court, has attracted wide attention. Like Justice Gray, he is a native of Massachusetts. He is a son and namesake of the late Dr. Holmes, the poet and essayist.

Justice Gray's Action Not Unexpected. Justice Gray's retirement was not altogether unexpected. It was recognized that he would be unable to resume his duties on the bench, and the general impression was that he would resign at or before the beginning of the next term of court in October. His successor, it is said, will not take his place on the bench until after his confirmation by the Senate. This is the written practice in the case of appointments to the Supreme Court. Justice Gray has been at Nahant, Mass., his summer home, for some time.

Judge Oliver Wendell Holmes. He is not like to be interviewed, and he has nothing to say, except that the Associated Press is the first to inform me of my appointment.

A Distinguished Scholar. Possessed of strong powers for diagnosis and analysis, his studies have been wide and varied, and he is in the broadest sense a scholar. He has not adopted the easy course of following legal rules, merely because they exist as such, without first tracing out their history and origin and their relation to the matter in hand. His opinions, which are published in the five volumes of the Massachusetts reports, are expressed in a fine literary style peculiarly his own, and they occasionally sparkle with wit.

He has generally reasoned and explained the law of the case in hand, citing such authorities by argument as justification and not copying in a wholesale manner general rules. His opinions are almost always brief and they are prepared generally with the view of making a return of value precedent when he has none to follow, and labor men have had occasion more than once to praise him for his decisions in cases of this kind. He has shown that workmen may combine for getting the most they can for their labor, just as capital may combine with a view of getting the greatest possible return.
