DAMAGE SUIT ON TRIAL.

Claim Growing Out of Alleged Violation of Jim Crow Law.

Hearing was begun today before Chief Justice Claiborn and a jury in Circuit Court No. 2 of the suit to law to recover damages in the sum of \$10,000, filed by Nelson Stanley Spencer against the Washington, Alexandria and Mount Vernon Railway Company. The plaintiff, who is a lawyer of New York city, and formerly a member of the civil service commission of the metropolis mentioned, came to this city in May, 1902, for the purpose of arguing a case before the Supreme Court of the United States. He visited Mount Vernon, and there boarded a train operated by the defendant company. He was refused a seat, and was arrested for having refused a request, made by the conductor, that he occupy a seat in the car other than the one he was sitting in at the time the request was made. Mr. Spencer contends that his arrest was illegal, and that the defendant should be held responsible therefor in damages. The defense is, simply that the plaintiff persisted in refusing to comply with the "Jim Crow" car law in force in Virginia. A hearing was held in the afternoon, and returned to Alexandria on Monday for trial and was represented by counsel. The judgment was one of guilty and a fine of \$100 was assessed. No appeal was taken, although counsel for the railroad company explained the right of appeal was open to Mr. Spencer.

ANOTHER VIEW PRESENTED.

Claim That Church Building Will Not Interfere With Park.

It is claimed by members of the Methodist Society who recently purchased two lots in Mount Pleasant whereon to build a house of worship that their plans can in no way conflict with the use of the lot at the corner of 14th street and Columbia road as a public park, as desired by the residents of Mount Pleasant. There have been several plans under consideration looking to the use of this ground for a park, and should Congress authorize the extension of School street down to Columbia road the lots recently purchased by the Methodist Society would be on the opposite side of School street from that part of the square now composed of the vacant ground that has been suggested for a park. This entire plot of vacant ground recently was subdivided into lots by the owners, and these lots are now on the market. It was said today by a representative of the owner that in the hope that this ground would be used for the purpose of a park, the owner had put off subdividing it as long as possible, but now it is subdivided and the lots are offered for sale.

CHARGE OF MURDER.

Eva De Veal on Trial in Criminal Court No. 1.

Eva De Veal, colored, was placed on trial today in Criminal Court No. 1 to answer a charge of murder. The grand jury has reported two indictments against the defendant. One asserts that she killed her new born infant, October 3 last, by bruising it and causing a contusion of the skull, while the other bill sets forth that she choked and suffocated the child.

Attorneys T. L. Jones and L. M. King, counsel for the defendant, asked that the government be required to elect upon which indictment it would go to trial, but Justice Pritchard overruled the motion. It was defended, however, that the two indictments be returned by the grand jury. The regular panel of jurors was exhausted before twelve men satisfactory to both sides were secured, so an adjournment was taken until 10 o'clock tomorrow morning. In the meantime the marshal will summon six additional talemans. Assistant United States Attorneys Turner and Gordon are conducting the prosecution.

DAMAGE SUIT ON TRIAL.

Claim Growing Out of Alleged Violation of Jim Crow Law.

Hearing was begun today before Chief Justice Claiborn and a jury in Circuit Court No. 2 of the suit to law to recover damages in the sum of \$10,000, filed by Nelson Stanley Spencer against the Washington, Alexandria and Mount Vernon Railway Company. The plaintiff, who is a lawyer of New York city, and formerly a member of the civil service commission of the metropolis mentioned, came to this city in May, 1902, for the purpose of arguing a case before the Supreme Court of the United States. He visited Mount Vernon, and there boarded a train operated by the defendant company. He was refused a seat, and was arrested for having refused a request, made by the conductor, that he occupy a seat in the car other than the one he was sitting in at the time the request was made. Mr. Spencer contends that his arrest was illegal, and that the defendant should be held responsible therefor in damages. The defense is, simply that the plaintiff persisted in refusing to comply with the "Jim Crow" car law in force in Virginia. A hearing was held in the afternoon, and returned to Alexandria on Monday for trial and was represented by counsel. The judgment was one of guilty and a fine of \$100 was assessed. No appeal was taken, although counsel for the railroad company explained the right of appeal was open to Mr. Spencer.

ANOTHER VIEW PRESENTED.

Claim That Church Building Will Not Interfere With Park.

It is claimed by members of the Methodist Society who recently purchased two lots in Mount Pleasant whereon to build a house of worship that their plans can in no way conflict with the use of the lot at the corner of 14th street and Columbia road as a public park, as desired by the residents of Mount Pleasant. There have been several plans under consideration looking to the use of this ground for a park, and should Congress authorize the extension of School street down to Columbia road the lots recently purchased by the Methodist Society would be on the opposite side of School street from that part of the square now composed of the vacant ground that has been suggested for a park. This entire plot of vacant ground recently was subdivided into lots by the owners, and these lots are now on the market. It was said today by a representative of the owner that in the hope that this ground would be used for the purpose of a park, the owner had put off subdividing it as long as possible, but now it is subdivided and the lots are offered for sale.

CHARGE OF MURDER.

Eva De Veal on Trial in Criminal Court No. 1.

Eva De Veal, colored, was placed on trial today in Criminal Court No. 1 to answer a charge of murder. The grand jury has reported two indictments against the defendant. One asserts that she killed her new born infant, October 3 last, by bruising it and causing a contusion of the skull, while the other bill sets forth that she choked and suffocated the child.

Attorneys T. L. Jones and L. M. King, counsel for the defendant, asked that the government be required to elect upon which indictment it would go to trial, but Justice Pritchard overruled the motion. It was defended, however, that the two indictments be returned by the grand jury. The regular panel of jurors was exhausted before twelve men satisfactory to both sides were secured, so an adjournment was taken until 10 o'clock tomorrow morning. In the meantime the marshal will summon six additional talemans. Assistant United States Attorneys Turner and Gordon are conducting the prosecution.

End of the World.

The lecture given yesterday at the First Colored Church of the New Jerusalem, corner 10th and V streets northwest, under the auspices of the Swedenborgian Reading Circle, was well attended. Rev. James E. Thomas, the pastor, delivered an address on "The End of the World." He said, in part, that the spiritual significance of the end of the world, as the world is a state of man when the natural light and stars shall become darkened because of the discovery of a greater light. It indicates the decrease of the letter by the increase of the spirit. After the addition of Governor Hoyt's address the program included a speech by Representative H. C. Adams, a recitation by Miss Maude Webster and solos by Mr. Thomas C. Ebrahym, Mrs. John W. Birchhoff and Miss Pickering.
