Thousands of the New Faith at Boston Convention. One of the most remarkable religious demonstrations ever witnessed in New England occurred at Boston yesterday, when the new \$2,000,000 Christian Science Temple, in the Back Bay district, was dedicated.

From every state in the Union and from all parts of the world came members of that faith to witness at the dedication.

It was estimated that more than 40,000 Christian Scientists were in the city yesterday. Six services were held to accommodate the vast throngs, but even then there were thousands who were unable to gain admission to the temple.
