





ATTENDED BY FAILURE EFFORT TO CAUSE TROUBLE OVER GLEN ECHO INCIDENT.

Alleged Excess of Speed Limit by German Embassy Secretary Not International Question.

Complete failure has attended recent efforts to make an international issue out of the recent experience of Mr. von Radowitz, second secretary of the German embassy, with the town marshal of Glen Echo, Md. The same statement applies equally to the effort to make an issue between the United States authorities and the governor of Maryland regarding the question of jurisdiction over the Conduit road in Maryland beyond the District line.

As has been already stated in The Star, the town marshal at Glen Echo intercepted the automobile of the German diplomatist in Glen Echo a few days ago on the ground that it was exceeding the speed limit, but when informed of the official character of the occupant he offered no further hindrance to its progress. It was charged that the marshal fired two shots from his revolver before the chauffeur would stop his machine. The marshal says he fired into the ground, but some other people say he aimed at the tires of the automobile. At any rate, no one was injured and the machine was not damaged.

The incident gave rise to many sensational statements, the most serious being that the German minister had been insulted through his secretary, and that the United States would be required to apologize for the action of the town marshal. Another statement was that the matter had been officially presented by the Secretary of State to the governor of Maryland, with the request that he discipline the town marshal and also instruct him that Maryland had no jurisdiction whatever over the Conduit road, etc.

But such instances are extremely rare in the history of the diplomatic service at large, for the very good reason that only men of the highest character are chosen for that service, and they are especially circumspect in their conduct in a foreign land, as otherwise, as has been stated, their usefulness would be seriously impeded. The explanation made by Mr. Radowitz that he did not know his automobile exceeded the speed limit is therefore regarded as much more plausible than is the charge that he deliberately violated the law because of his immunity from punishment.

Seldom Invoke Privilege.

Although the members of the diplomatic corps are immune from arrest, it is very seldom that they have occasion to invoke that privilege. It is one of the elementary principles of their creed to study the laws and customs of the country to which they are accredited and to strictly conform to them. Otherwise, it is declared, they would become persona non grata, and if not recalled home would be given their passports. That course would surely follow in the case of any diplomatic representative who willfully or persistently violates the laws of the country to which he is accredited. But such instances are extremely rare in the history of the diplomatic service at large, for the very good reason that only men of the highest character are chosen for that service, and they are especially circumspect in their conduct in a foreign land, as otherwise, as has been stated, their usefulness would be seriously impeded.
