New York Chemist, Caught With Explosive in a Valise, Held at St. Louis.

CHICAGO, March 12.—Dr. Herman Bodenheim of New York city, a chemist, was held under arrest by federal

authorities in St. Louis today on a charge of violating the federal law, which prohibits the shipping of high explosives on passenger trains.

The arrest of Bodenheim was caused last night by E. O. Claiborne of Chicago, division superintendent of the federal bureau of investigation.
