

TRUST COMPANIES' DEED MAY NOT BE GRANTED Reserve Board Has Expressed Views on Rights of Member Banks in District.

National Metropolitan to Install Savings Department April 1. Treasury Deficit Is Larger.

It is scarcely probable that the federal reserve board will take any action in the application of the local trust companies of the District for a hearing on the question of national banks being given the privilege of acting as executor, administrator, trustee or registrar of stocks and bonds.

The answer of the board was to the effect that the laws of the District, being made by Congress, it did not have any local laws, hence the action of Congress in passing the federal reserve act gave to the board the right to grant such privileges to national banks.

The national metropolitan bank, one of the oldest institutions in the city, the first to apply for the permission to assume trust company privileges under the federal reserve act, has decided to install a special department for the handling of such business.

There was very little interest in the market for local securities on the exchange last night. Sales were generally of small lots and prices showed no important changes.
