PROPOSITION AROUSES FINANCIAL DISTRICT. Implied Threat of Wholesale Curtailment of Purchases Here Should Plan Be Rejected.

NEW YORK, September 14. -The report that Anglo-French financial commission contemplated borrowing a billion dollars here without collateral of any sort and solely on government notes of Great Britain and France overshadowed all other topics in the financial section today.

Whether a strict interpretation of American neutrality would permit the issuance of a straight commercial loan on bonds of two of the allied warring nations was a topic of considerable conjecture.

AUSTRIAN STATEMENT. VIENNA, September 13, via London, September 14. The Russian attacks on the east Galician front continue. On the Serch strong hostile forces were repulsed at several points.

ITALIAN STATEMENT. ROME, September 13, via Paris, September 14. On the plateau to the northwest of Arserio the enemy's artillery persistently shelled our positions on Monte Amiana throughout the night of the 12th, but without any result.

RUSSIAN STATEMENT. PETROGRAD, September 13, via London, September 14. In the Riga and Friedrichstadt districts no essential change has occurred. On the front of the Lower Ekau and northwest of Mitau there have been minor engagements between small detachments.
