ARMY AND NAVY UNION HAS NO D. C. DEPARTMENT

The District of Columbia Department of the Army and Navy Union at its annual encampment, held in G. A. R. Hall last night, voted not to reorganize at this time. HEMP DAMAGED BY TYPHOON.

Gov. Gen. Harrison Reports on Storm in Philippines.

Governor General Harrison of the Philippines has cabled the insular bureau that the typhoon which passed over the provinces of Albay, Samar, Camarines, Sorogon and Tayabas, in southern Luzon, the principal hemp-producing district of the islands, October 23 and 24, caused serious damage to the hemp crop and some loss of life. HEMP DAMAGED BY TYPHOON.

Gov. Gen. Harrison Reports on Storm in Philippines.
