


FINAL RITES TOMORROW FOR CAPT. J. E. WHITE

Former Superintendent of Railway Mail and Union Veteran of Civil War.



Funeral services for Capt. James E. White, who died at the Stratford Hotel, in this city, Friday afternoon, will be held at the Fourth Presbyterian Church, 13th and Fairmont streets northwest in this city, tomorrow afternoon, at 2 o'clock.

Up to February, 1907, Capt. White, who then resigned the position of general superintendent of the railway mail service, was one of the most widely known officers of the postal service.

Record of Army Service. Capt. White enlisted in Company J, 3d Regiment, Iowa Infantry, May 20, 1861, at Vinton, Iowa; was wounded September 17, 1861, at Blue Mills, Mo.; was subsequently transferred to Company G, 13th Iowa Volunteer Infantry, January 1, 1862; promoted to fourth sergeant, April 30, 1862; to first sergeant May 1, 1862, and was commissioned second lieutenant April 29, 1863; was again promoted July 21, 1864, near Atlanta, Ga.; and was assigned as first lieutenant October 5, 1864, as captain January 1, 1865, and was mustered out of the service at Louisville, Ky., in March, 1865; the line was extended as designated as the Clinton and Boone railway post office. He served as postal clerk at Chicago, Ill., and Nebraska, and then the Chicago and Northwestern railroad between Cedar Rapids and Booneboro, Iowa, in March, 1865; the line was extended as designated as the Clinton and Boone railway post office. White was a member of the Military Order of the Loyal Legion of the United States, commandery of the District of Columbia, and was for years prominent in Masonry in the District, having been a member of Harmony Lodge, No. 17, F. A. M.; Columbia Chapter, No. 1, Royal Arch Masons, and of Columbia Commandery, No. 2, Knights Templar. He demitted from these bodies, however, some years ago. He was also a member of Almas Temple of the Mystic Shrine.

Would Tax Explosives Made in U. S. An amendment to the forthcoming House revenue bill providing for a tax of 2 cents a pound on all explosives manufactured in the United States and of 10 per cent ad valorem on all munitions of war manufactured here was introduced in the Senate today by Senator Robinson of Arkansas. WAR OFFICIALLY REPORTED

AUSTRIAN STATEMENT. VIENNA, January 23, via London, January 24: Southeastern theater: The surrender of Montenegrin arms continues in numerous parts of the country. On the northeast front of Montenegro more than 1,500 Serbians have surrendered. The Adriatic ports of Antivari and Durrës have been occupied by our troops. Russian theater: Friday we blasted a Russian trench on the Dolzok heights north of Boyan, on the Pruth. Of the 200 men occupying the trench only a few escaped. During the course of Friday night our troops expelled the enemy from one of his intrenchments in the same region. Northwest of Usciocka a fortification organized by us has been the object for a long time of numerous Russian attacks. Almost daily hand-to-hand fighting occurs, but the defenders withstand all assaults. Dubno the night of this morning, after a violent artillery preparation, attacked our positions. The enemy has been repulsed with heavy loss. Italian theater: There have been artillery engagements on the Tolmino bridgehead and the western sector of the Carnian ridge and several parts of the Tyrolean front. In the region of Filzsch an attack on the Robion slope was repulsed. One of our aviators dropped bombs on an Italian storehouse at Boz.

GERMAN STATEMENT. BERLIN, January 24, by wireless to Bayville: Western front: There have been lively artillery and aeroplane actions. An enemy squadron bombarded Metz, where bombs fell on the bishop's dwelling and on a house in the upper part. Two civilians were killed and eight wounded. One aeroplane was shot down and its inmates were made prisoners. German aviators bombarded railroad stations and military establishments behind the enemy's front. In several air engagements the Germans had the upper hand. Eastern front: German artillery shelled and set on fire a Russian railroad station north of Dvinsk. Bombs from a Greek air squadron, coming from Greek soil, bombarded Monastir. There were several casualties killed and wounded among inhabitants.

ITALIAN STATEMENT. ROME, January 23, via London, January 24: On the slopes of Nozolo, in Giudicaria and north of Mori, in the valley of the Lagarina, hostile detachments which tried to approach our positions were repulsed with a counter attack. Borgo, in the valley of the Sugana, again was the object of a bombardment by artillery and bombs from one aeroplane. In reprisal we fired on the station of Caldonazzo, damaging it. Our detachments at Lagazuoli, in the Falgaro zone, and Corneil Piano, in the upper Rienz valley, threw bombs on the enemy, putting them in confusion. By way of reprisal for the enemy's aerial attack of Dogna our batteries have bombarded Tarvis. A bomb falling on the town has interfered with the artillery action. A petty attack by the enemy on a sector of Santa Maria was repulsed.

BRITISH STATEMENT. LONDON, January 24 (statement dated January 23): There has been some mining activity at Marcourt, Hulluch and Givency. We successfully approached our positions in the Russian and Freilinghen. Sir Percy Lake (the new commander in Mesopotamia) reports that Gen. Asyl attacked the Turkish position at Esnin Friday. Pierce fighting continued through the day, with varying success. The weather throughout was atrocious, a pouring rain rendering movements of troops extremely difficult. Owing to the floods it was impossible to renew the attack Saturday, and Gen. Asyl took up a position 1,300 yards from the enemy's trenches. The weather continues very bad, with incessant rain. No details regarding the casualties have been received, but they are reported to have been very heavy on both sides.

TURKISH STATEMENT. CONSTANTINOPLE, January 23, via London, January 24: Caspian front: On the center there has been unimportant artillery fire; on our right wing there have been cavalry engagements. Otherwise there is nothing to report. A telegram from the Persian frontier says that a Turkish detachment and French warriors who applied to occupy Kankevar, between Kermanshah and Hamadad. The Turkish troops and native warriors continue their advance. Assadabad and Chakparkam are again in their possession. They repulsed a Russian cavalry regiment which undertook to attack in the direction of Miadabad. The Russian losses were about a hundred killed. A Russian regiment has been defeated south of Urumiah. One of our airmen dropped bombs successfully Friday on the camp and works at Monchy. The island of Tenese was shelled on the island of Tenese. Friday morning a warship of the enemy shelled the Turkish coast at Adul-Bahr, on the Gallipoli peninsula.

RUSSIAN STATEMENT. PETROGRAD, January 23, via London, January 24: In the Riga sector, near the Mitau road, the Germans bombarded our intrenchments with artillery shells. Near Pulkrain, on the Bausk road, skirmishes occurred between German detachments and parties of our troops. Caucasus theater: The precipitate retreat of the Turks in the region of

PASTORS PAY TRIBUTE TO THE JEWISH RACE

Held to Be Greatest Contributor to Modern Civilization and Founder of Democracy.

Tribute to the Jewish people was paid by a number of Washington pastors yesterday in anticipation of Jewish War Relief day Thursday, fixed by President Wilson in response to a resolution passed by the Senate. "We owe the democracy of this country to the Jew, for it is the outgrowth of the synagogue," said Rev. Hugh T. Stevenson, pastor of Bethany Baptist Church.

"The Scriptures owe to the Jew: we must remember that Jesus Christ was a Jew, that He entered the human race through the Jewish line. The constitutions of the Jewish people came from the Jew, for the synagogue is recognized as the oldest democracy in the world." "The Miracle of History." Rev. Dr. James Shera Montgomery referred to the Jew as "the miracle of history." He said, in part: "We meet him at every turn. He is the greatest contributor to modern civilization, in the governmental idea, the family idea and in ethics. While Greece gave us estheticism and philosophy, Palestine gave us Jesus and the Bible. The more we have of and study the Jew the more we are fascinated and even astonished. From the Jew we have gleaned much in our science, philosophy and ethics. "In every realm of human endeavor Rev.
