NO D. C. DELEGATES ON THE TEMPORARY CONVENTION ROLL

National Committee Declines to Enter a Decision in Triangular Contest.

CREDENTIALS COMMITTEE MUST PRONOUNCE VERDICT

Hair-Raising Stories of Riot and Corruption to Be Told All Over Again.

BUSY DAY OF WHISPERING

Local Politicians Haunt Ante-Room and Buttonhole Committee Men Whenever Opportunity Is Presented.

CHICAGO, June 6.—Well, they danced around the May pole, and they all fell down, with the pole on top.

This is the plight of the rival delegates from the District of Columbia. Three contesting delegations, the only triple-ringed circus that appeared before the national committee, have been politely told by the committee that nobody from the District of Columbia shall have a seat on the floor of the convention at the opening of the big show, but that the credentials committee must find out the real truth about republican politics in Washington and determine who, if any one, shall be allowed to sit in the permanent organization.

And, in passing, the whole proceeding shows the most dire need for a set of election laws to govern primaries in Washington.

Slow Getting Under Way. They all arose bright and early yesterday morning. Breakfast over before 9 o'clock, the rivals, in groups of two and three, meandered down to the Coliseum, where it was presumed the District of Columbia contest would be staged at about 10 o'clock in the morning.

Several southern contacts were on ahead of the District case and they were dragged out into an interminable length, until it looked as if the sun would sink behind Lake Michigan before the political triangle from the National Capital would be brought in for inspection.

All during this wait some of the grandest pussy footing was going on in the ante-room, just outside the sacred precincts of the national committee. Should a national committee man stick his head out of the door some one would grab him, lead him off to the corner and put the matter up to him as between friends.

Sidney Bieber, who is here with rubber heels and a mysterious side glance, grabbed off the national committee man for the Hogan-Williston ticket. Aaron Bradshaw did his own grabbing.

Brown on the Inside. Chapin Brown, national committee man for the District of Columbia, was, of course, inside the committee room attending to his own knitting, but Robert Miller and Calvin Chase stayed out in the meadow, as it were, and pursued a large, imposing looking man who puffed and panted and wore an endless array of badges.

Barry Bulkeley, who seems to be taking a keen delight in watching the entire performance, sat out in the lobby and smiled with his own inimitable smile, and Franklin Pierce Morgan, who was once a democrat, but now declares he will be

a republican forever and ever, joined the silent parade of pussy footers and attended to a lot of little matters in a political way.

Whispering to national committee men continued in this fashion for a space of six hours. All records for sustained whisper work were shattered. Even "Uncle Joe" Cannon, who came in the midst of an applause, was beset by his whisper squad and, although he looked simply bored to death, he had the people beside him all three sides poured into his unwilling ears. All of which was most futile, because "Uncle Joe" is a national committee man and, besides, he came here to enjoy himself.

Hunger and Heart Disease. Another hard job that befel the whisper squad was in keeping the national committee tied to its seat. Just about the time one of the rival factions had hypnotized a member to vote the right way that member would get hungry and want to get a bite to eat. The sight of one of those gentlemen leaving the hall gave the delegates affected a fine case of heart disease. Finally, however, the hungry were all fed by the District of Columbia circus started, and a full house greeted the affair.

When it started, it opened the eyes of a few amateurs of the state of affairs that went on in Washington the eventful day when a city of 380,000 people cast less than 8,000 votes for representation in this convention.

The national committee heard tales of riot and near bloodshed and this being the case they had set Raymond Pullman's hair to rising. They heard words of fraud which were painted in words that would describe the size of the Rocky mountains, and used to describe the alleged trickery that could be found in a broad lot of ballots. One speaker, whose recitation rivaled the majestic sweep of a walking beam, told in horrendous tones many stories of intimidation and violence. The other speaker, an attorney employed here in Chicago, stood before the national committee and told them of the casting of these ballots resulted in "riots and everything short of murder."

Senator Snoot, who might be said to know a little something about Washington, after hearing considerable of this, suggested that the noise be stopped and a few real facts produced.

Hogan's Feelings Hurt. One of the charges against Frank J. Hogan, was that he loaded up sightseeing automobiles with repeaters and went around from polling place to polling place.

"I am sorry to hear these attacks upon my integrity," replied Mr. Hogan, "but I am also grieved at this reflection upon my intelligence. To try to conceal repeaters in sightseeing automobiles would suggest that there is something wrong in my brain, and that is not even true. I had a good deal of a fight at the polls that couldn't have been quelled by the entire National Guard if I had called out the proportions charged. Mr. Hogan jumped up and shouted:

"No streets were made that day, and there were from two to five policemen at every polling place. You know Washington, Senator Snoot, and you know his police force. This is a democratic administration in Washington and God knows the democratic administration has no use for me."

And so they went on. The Miller-Chase people claimed that there was so much fraud in the election that all the Hogan ballots were tossed out. The Hogan people claimed that this was all a very crook, and that the returning board which was endeavoring to seat Miller-Chase was three days in framing up something and that even then it failed and had to write out a fake certificate. Yes, that's the way it is, but it's just as mild as skinned cats and it's just as good as the things they fired at one another.

Aaron Bradshaw Plays 'Possum. And all the time Aaron Bradshaw played 'possum and didn't say a word. When he finally broke his silence he just calmly declared he wasn't interested in these charges of stuffed ballot boxes, and all that. He was just the rightful candidate, anyhow, the only one elected according to Hoyle and the rules of the national convention, and that's the whole thing in a nutshell.

Furthermore, Aaron Bradshaw alleged he was the oldest living republican in the District of Columbia. He said he knew every real republican by sight in Washington, and that when he sized up the unscrupulous mob who voted for Hogan there were only two republicans there, the rest, he declared, were all democrats.

One of the interesting features of the testimony, if such it may be called, in the national convention, was the presentation of affidavits by Clayton Denver, a newspaper reporter. The Miller-Chase folks made a grandstand play with one of Mr. Denver's pen productions, in which he told a tale of riot and corruption. Whereupon Mr. Hogan arose and displayed a Clayton Denver affidavit in which he averred that upon the day of the election all had been quiet on the Potomac, and no ruffie disturbed the serenity of the scene.

Dustpan for the Lot. After one and a half hours of attempts at seeing who could make the greatest claim of riot, the national committee asked the participants to retire. It was then that the big broom was taken down from behind the door and all three delegations were shoved into the dustpan.

The next move will be made before the credentials committee, and by that time, unless the orators curb themselves, the dustpan will be empty.

Election Board's Confidential Report. The confidential report of the election board—Charles Linkins, Charles H. Bauman and Jesse H. Foster—which was addressed to the republican national committee, certifies the election at the primaries in the District of Columbia of Robert J. Miller and W. Calvin Chase as alternates, and of Arthur B. Hayes and Albert R. Collins as alternates to the national convention.

A long statement by the board is contained in the report, summarizing charges made in a group of affidavits which are also printed in the report, to the effect that the Hogan-Williston tickets were "in bunches" which apparently had not been separated into individual ballots, but were in connection with alleged stuffing of the ballot boxes with Hogan-Williston tickets.

Declaring that "mob violence prevented the returning board from carrying out the directions of your election board," and "prevented by mob force representatives of one of the other two tickets from even entering the building," the confidential report, goes on to say: "Their actions became known to the returning board, and your election board were required to go to the place of meeting of the returning board, with the instructions carried out, but they were attacked by the mob that had gathered there expecting to have the Hogan-Williston ticket, and the chairman of the election board was assaulted and could be found in a broad lot of ballots that it took several days for him to recover therefrom, this being done without any effort of your election board, except to try to quell the mob violence. The affidavits of several of those who took part in this mob attack, and told them that they attacked the chairman of your election board are attached hereto."

Alleges Presence of Hogan "Mob." In another part of the statement in the confidential report, reciting what is alleged to be the experiences of Edgar Snyder, chairman of the returning board, it is stated:

"When he arrived, notwithstanding the agreement with Mr. Snyder, the representatives of the tickets should be present, Mr. Snyder found a large mob congregated in the interest of Mr. Frank J. Hogan, and that the mob—after repeated refusals on the part of Mr. Snyder to act in the interest of the returning board—was appointed, with threats of violence and of his life—demanded that they should be brought to the returning board by the agents of Mr. Frank J. Hogan, in violation of the provisions of the call for election. After over two hours of resistance, and after positive word had been sent by Mr. Snyder to the effect that they should be made, in order to preserve peace and even life a count was taken of the mob, and it was found to be 100."

The report declares that the so-called "convention" which selected as delegates Aaron Bradshaw and Dr. Charles H. Marshall, and an alternate Angus A. Ely and L. Melendez King, was unauthorized, and that no election of delegates to local convention was had, could be had, and that the matter was simply a sham.

FIGHT OVER SUFFRAGE EXPECTED AT ST. LOUIS

Interest Centers in Part Bryan Will Play in Democratic Convention.

ST. LOUIS, June 6.—A smart fight—the only one visible on the sky-line of the coming democratic national convention—is anticipated by national committee men over an effort that is to be made to write into the party's platform an equal suffrage plank.

National Chairman McCombs said today he had been advised that the same suffragist host that is to wage a fight for the suffrage plank at the republican convention would appear in force at the St. Louis convention.

Women to Have Hearing. Members of the committee on resolutions coming from suffragist states will in all probability, the leaders say, make a fight for the incorporation of a suffrage plank. National committee men agree that the woman suffragist leaders will be given every opportunity to make their pleas to the platform committee.

Mr. Carrie Chapman Catt, president of the American Woman Suffrage Association, with representatives from several women's organizations, are to attend the convention. J. Bruce Kremer, secretary of the committee, has announced that the business reasons would prevent his being a candidate for re-election. No names have been suggested for Mr. Kremer's successor.

Bryan Likely to Speak. Several committeemen have made inquiry as to what part, if any, William J. Bryan will play in the coming convention. It was officially stated that as a delegate nor as an alternate he could only speak to the convention with the unanimous consent of the delegates. Under convention rules Mr. Bryan can obtain a proxy by the withdrawal of a delegate and his alternate.

Thursday will be a general speech-making day and the committeemen here now say Mr. Bryan will probably be asked to speak on democracy.

CHURCH FIGHT PROVES FATAL

One Killed, One Mortally Hurt and Six Shot at Jackson, Ky.
