STREET CAR COMPANIES TO IMPROVE SERVICES

Public Utilities Commission Makes Order Following Observation of Traffic.

Orders to operate additional cars were served on the Capital Traction and Washington Railway and Electric Companies today by the public utilities commission.

The commission states that its action is based on a study of traffic observations, and that the extra cars are required to bring the service up to the standards adopted for the District by the commission.

With respect to the Capital Traction Company, the order is as follows: New Jersey avenue line, eastbound, one additional car, between 7:30 and 7:45 a.m.

Pennsylvania avenue line, passing 17th street and Pennsylvania avenue northwest, westbound, three additional cars between 8:15 and 8:45 p.m.; three between 6:30 and 7 p.m.; one between 7:15 and 7:30 p.m.; one between 7:45 and 8 p.m.; eastbound, one between 7:15 and 7:30 a.m.; ten between 6:30 and 7 p.m., and one between 8:15 and 8:30 p.m.

Florida avenue line, passing New Jersey and Florida avenues, westbound, two more cars between 8:15 and 8:45 a.m.; eastbound, one between 5:45 and 6:15 p.m.

Line running south of the Capitol, passing Peace Monument, westbound, one more car between 7:45 and 8 p.m.; eastbound, two between 3:15 and 3:30 p.m.

The order affecting the Washington Railway and Electric Company follows: Line passing North Capitol street and New York avenue, westbound, one car between 8:15 and 8:45 a.m.; two between 9:30 and 10:15 a.m.; eastbound, four between 8:30 and 8:45 a.m.; five between 7:45 and 8 p.m., and one between 9:30 and 10 p.m.

Line passing North Capitol and H streets, southbound, five more cars between 7:45 and 8:45 a.m.

Line passing Delaware avenue and B street, northbound, one more car between 8:15 and 8:45 a.m.

Georgetown line, passing Dupont Circle, westbound, two more cars between 8:15 and 8:45 p.m.; eastbound, one between 7:30 and 7:45 p.m.; one between 8:30 and 8:45 a.m.

Tennallytown line, passing Wisconsin avenue and R street, southbound, one more car between 8:15 and 8:45 a.m.; eastbound, four between 3 and 3:45 p.m.; five between 6 and 7:45 p.m.; and one between 9:30 and 10 p.m.

Mount Pleasant line, passing Dupont Circle, northbound, one more car between 6 and 6:15 p.m.; eastbound, three between 8:15 and 8:45 a.m.

Maryland line, passing North Capitol street and New York avenue, westbound, one more car between 8:15 and 8:45 a.m.; eastbound, four between 3 and 3:45 p.m.; five between 6 and 7:45 p.m.; and one between 9:30 and 10 p.m.

The Washington Railway and Electric Company has notified the commission that on account of a lack of trainmen on October 31, it was unable to maintain its schedules on the Mount Pleasant, Georgetown, North Capitol street, Maryland and 13th and D streets lines.

May List Places for Rent. Officials of the Washington Chamber of Commerce today are considering a suggestion made by the Civil Service Commission that the commercial body should list houses and buildings now available which might be used for residential or other purposes.

Moving Into New Quarters. The Washington Chamber of Commerce today is moving from the quarters it has occupied at 1202 F street northwest for years into the second floor of 611 12th street northwest. The Chamber of Commerce has leased the room for one year.

PLAN CO-OPERATIVE GROCERY. Post Office Department Employees Name Managing Committee.


Plans are being made by the Post Office Department to organize a co-operative grocery store for the benefit of that department, the city post office and other employees of the postal service in Washington.
