

ANTI-ANARCHY BILL PASSED.

Purpose is to Protect President, Cabinet and Ambassadors.

WHAT MEASURE PROVIDES.

Death Penalty for Killing Officials Mentioned in Bill—Fine and Imprisonment for Murder Advocates.

Washington, June 8.—The house passed the bill to protect the president, vice president, members of the cabinet and foreign ministers and ambassadors and to suppress the teaching of anarchy by a vote of 175 to 23. The negative votes were: Adams, Bartlett, Brantley, Brundage, Burleson, Chandler, Cooper (Texas), Creamer, Dearmond, Dismore, Finley, Fow, Glenn, Henry (Mississippi), Hooker, Howard, Johnson, Jones (Virginia), Claud, Kitchin, W. W. Kitchin, Kieberg, Lanham, McCullough, McLaughlin, Maddox, Neville, Patterson, Shackelford, Spight, Stevins (Texas), and Underwood.

A motion to recommit the measure, with instructions to strike out certain sections, was defeated, 71 to 123.

The remainder of the day was devoted to the bill to transfer certain forest reserves from the interior department to the agricultural department and to authorize the reclamation in such reserves of game and fish preserves. President Roosevelt, in his annual message, recommended such a measure.

The minority of the public lands committee offered a senate substitute for the bill, a measure which eliminated the reserves to the agricultural department. Messrs. Lacy (Iowa), Kieberg (Texas), Perkins (New York) and Williams (Mississippi) spoke in favor of the bill. Messrs. Mondell (Wyoming) and Shafrath (Colorado) supported the minority substitute. Mr. Bell of Colorado opposed the bill in toto. No vote was reached.

Mr. Pitt, from the committee on foreign affairs, presented a resolution which after reciting the fact that peace has been established in South Africa, calls upon the secretary of state for a complete list of American citizens now detained as prisoners of war in South Africa, and for information as to what action is being taken to secure their release. The resolution was adopted without division.

The bill passed today by the house for the protection of the president is a substitute for the senate measure which contained no anti-anarchy provisions, but did contain a provision, omitted in the substitute, for a body guard for the president.

The substitute consists of thirteen sections. It provides that any person who shall unlawfully, purposely and knowingly kill the president or vice president or any foreign minister or ambassador or minister accredited to this country, "while engaged in the performance of his official duties or on his way to or from such duties or on his way to or from such duties," shall suffer death.

Any person who attempts to commit any of the above offenses shall be imprisoned not less than ten years.

Any person who is engaged in an unlawful attempt to inflict grievous bodily harm upon the president or any person entitled to succeed him, if he inflicts injuries which cause death, shall be imprisoned for life. If such injuries do not cause death, such offender shall be imprisoned not less than five years.

Any person who aids, abets or conspires with another to commit any of the above offenses shall be deemed a principal. Any person who knowingly harbors, conceals or aids with intent that he may avoid arrest or punishment any person who has committed any of the above offenses shall be imprisoned from one to twenty-five years.

Any person who advocates the unlawful killing of an officer of this government or of a member of any organized civilized nation because of his official character, or who openly justifies such killing with intent to secure the commission of any of the above offenses, shall be fined not more than \$5,000 and imprisoned from one to twenty years.

Any person who conspires or advises any person to assault or kill, without or without the United States, the chief magistrate of a foreign country, or the cause of his official character shall be punished as follows:

If the attempt is made and death results such offender shall suffer death. If such attempt does not result in death the punishment shall be a fine of \$500 to \$5,000 and imprisonment from five to twenty-five years. If such attempt is made and the offender shall be a soldier, sailor or mariner he shall be imprisoned from one to five years.

Section eleven provides that no person who is opposed to all organized government or to a member of any organized nation maintaining or teaching such opposition shall be admitted into the United States, and that any person who aids such person to enter shall be fined not more than \$5,000 and imprisoned from one to five years.

Section twelve prohibits the naturalization of anarchists and empowers the courts to investigate before issuing final papers to require the affidavit of the applicant affirming the truth of every material fact necessary for naturalization.

The last section of the bill provides that in all prosecutions under the first seven sections of the act it shall be presumed until the contrary is proven that the president or other officer was engaged in his official duties at the time of the offense.

Watching for Col. Lynch. New York, June 10.—Detectives are watching for the steamer captain, James Lynch, who is the London correspondent of the Tribune, in anticipation of the arrival of Col. Lynch.

Matt Tobin of Salina, Kan., Dead. Salina, Kan., June 10.—Matt Tobin, a pioneer of this state, is dead in this city, aged 105 years. His first wife died in 1830, and his second wife, who survives him, is 95 years of age.

Beneficiaries of Cuban Amnesty. New York, June 10.—There are perhaps a dozen persons who will benefit by the amnesty act just signed by President Palma, including two or three Cubans from Connecticut. Havana says a Havana dispatch to the Tribune, Estes G. Rathbone and C. P. W. Neely, who were convicted of postoffice frauds amounting to many thousands of dollars, will receive pardon. Neely has been in prison two years of his sentence of eight years; Rathbone is out on \$10,000 bail, awaiting a decision of the supreme court. His sentence was for eight years. News that he is to be a free man in a day or two failed to arouse Neely from the indifference that he has maintained since he was arrested. He smiled, but showed no particular interest in the information.

"I have been here 25 months," he said, "and I will be released, set out. I must say, though, that I have been very well treated by the Cuban prison authorities. I am in excellent health, notwithstanding reports that I am suffering from consumption. I am not on any definite plan. I probably shall remain here a week or two, then go up to the states. Perhaps I shall take up some business scheme here in which I was interested at the time of my conviction."

Sale of Valuable Americana. New York, June 10.—An interesting sale has been opened here, says a London dispatch to the Herald, of a portion of the valuable Americana collection by Marshall C. Lotters, of New York.

The lots include rare works on Indian wars, witchcraft, state and local history, etc.

The first day's sale saw over 150 old books and manuscripts disposed of for \$1,000. The highest price for a copy of the Bible translated into the Indian language, ordered to be printed by the commissioners of the United Colonies in New England, dated 1663, which sold for \$1,500.

The following were among the most valuable literary curios sold:

"Good Order Established in Pennsylvania and New Jersey," a little volume, which bears the distinction of being the first book printed in America by William Bradford, Philadelphia, dated 1685, \$25.

"Indian Wars in New England," being a complete set of five rare folios, published from 1675 to 1677, \$245.

"A True Discourse," by Ralph Hamor, of the state of Virginia, and the success of affairs there until June 1614, \$40.

Sulphur Springs Unusually Active. Santa Fe, N. M., June 10.—The United States geological survey has been notified by Capt. J. P. Conner of this city, that the sulphur springs in Bernalillo county are showing unusual activity. There are some 25 springs among the springs, each with every thirty seconds. The latest geyser, which has been quiet as far as the memory of man extends, is reported to be sending up a stream five feet high.

A Contortions' Bad Fall. Grand Rapids, Mich., June 10.—During the performance of a circus here last night, Mlle. Naoma Ehrhard, a contortionist, fell while performing upon a horizontal bar. She struck upon her head, rendering her unconscious, from which condition she had not recovered when the show left the city late at night. Her injuries may prove fatal. Her husband and two children are also performers.

To Combine Ship Building Yards. New York, June 10.—All but the merest formalities of the plan to combine several of the big shipbuilding yards of the country under one management have been completed, according to the Herald. A few papers remain yet to be signed, and for this purpose a meeting of the interested parties will be held today, after which a formal announcement will be made and the securities of the new corporation will be placed on the market. In spite of the extreme reticence of the men who are promoting the formation of the combination, it was learned that the plan contemplates a plant which will turn out any kind of vessel, from a tramp ship of small dimensions to a battleship weighted down with the heaviest of armor. Iron and steel works are being sought for, and it is understood that an extensive plant has been purchased. Lewis Dixon, the shipbuilder, who resigned recently the leadership of Tammany Hall, and who has been most active in bringing about the combination, refused, however, to discuss his plans.

Melters Quit Work. Pittsburgh, June 10.—About 600 melters employed by the Crucible Steel company in Pittsburgh and Allegheny, Pa., have quit work as a protest against the present wage rates.

The company's members in the big steel plant at Lawrenceville also threaten to strike. Frank B. Smith, general manager of the Crucible company, says the differences will be adjusted at once.

Dr. Freeman was born in New Hampshire in 1809. He continued practicing to within five days of his death.
