

TECHNOES FROM THE BOXING CONTEST.

EDDIE ROBINSON'S VERSION.

SPRING WON RACE. Captured Twenty-five Mile Event in 2 Hours and 42.5 Seconds.

Boston, April 19.—Michael Spring of the Pastime Athletic club of New York won the Marathon race of twenty-five miles today, covering the distance in two hours, 42 minutes and 42.5 seconds (the second fastest time since the race was inaugurated and the minutes being the record, which was made in 1901 by J. J. Fitzroy of Hamilton, Ont. T. J. Hicks of Cambridge was second, his time being 2:35:34.1-5, and E. P. Cook of South Boston third, in 2:42:25. The race was viewed at different points along the route from Ashland to this city by 100,000 persons.

A feature was the work of S. A. Mellor, Jr., of the Mohawk Athletic club of New York, who won the race two years ago. Mellor took the lead at the start and maintained it until within three miles of the finish, when he was seized with cramps, which caused him to drop to a walk. Mellor and Spring were the two leaders for fifteen miles, until Mellor became faint. He finished sixth.



THE BATTLESHIP VIRGINIA AND HER SPONSOR, MISS GAY MONTAGUE.

Miss Gay Montague, the thirteen-year-old daughter of Governor A. J. Montague of the Old Dominion State, is the pretty sponsor of the powerful new battleship Virginia. The Virginia is one of a group of five sister vessels authorized by congress in 1900, the others being the Rhode Island, the Nebraska, the New Jersey, the Nebraska and the Georgia. These will be among the greatest fighting machines in the world. Each ship has a displacement of 15,520 tons and carries a Krupp steel complete water line belt eight feet deep, with a maximum thickness of eleven inches at the top and eight inches at the bottom, tapering off gradually to four inches at the ends. The armament consists of four twelve-inch breechloaders in pairs in turrets, four eight-inch breechloaders in superposed turrets, four eight-inch breechloaders in pairs in turrets, one on each beam at upper deck level; twelve six-inch quick firers and thirty-two other quick firing and automatic guns of light caliber. There are no torpedo tubes.
