

the right to do it." was the answer. "If one of the Lord's servants should go to a woman and would condemn him and bring charges, after first going to him personally, it is a rule of the Church that a person aggrieved should go to the person offending before coming to any other person."

In answering a question as to his belief in modern prophecy, Senator Smoot said: "I am speaking today under the inspiration of the Lord—their counsel is just as good as that of the prophets that spoke under inspiration in ancient days."

ENDOWMENT CEREMONY. Senator Burrows interrogated Senator Smoot regarding the details of the endowment ceremony.

"How long did it take to perform this ceremony?" "From the beginning to the end about three or four hours."

"How many went through with you?" "Thirty or forty."

"State what you are able to recall of it?" "I would very much prefer not to."

"For conscientious reasons, I made a vow, not an oath, with my God, with my man, not with a living soul, but I did make a vow that I would keep the endowment ceremony sacred and not reveal them to anybody and I have kept that all my life, and if I went out of the Church tomorrow and remained out of the Church until I was gray-headed, I would never feel that it was my duty or that I should divulge what little I even remember of them."

The senator was asked a number of other questions regarding the ceremony which he preferred not to answer.

"Do you know why the oath of secrecy was imposed?" "It is purely a religious ordinance—refers absolutely to a man's hereafter, and has nothing whatever to do with anything other than man's relation to his God, and I suppose that it is an ordinance of the Church and the rule is that it be not revealed."

The senator said he did not belong to any other secret Church organization.

REGARDING TITHES. "Do you know how much money is paid into the Church annually in tithes?" asked Senator Overman.

"I could not say, except as a guess. As much as a million dollars."

"Some years more and some years less, I understand."

"Well, there is about \$100,000 for educational interests; about \$100,000 for the feeding of the poor, and about \$100,000 for the expenses of missionaries."

At this point Senator Overman interrupted, saying that all he wanted was information as to the Church investments in industrial and commercial institutions.

"The Church has some money so invested, but a small per cent of the capital of those institutions is held by the Church. He then gave a detailed statement of the stock held by the Church in various institutions, said to be controlled by the Church, to show that in nearly every case the Church holds a minority of stock."

CROSS EXAMINATION CLOSED. Judge Taylor announced then that his cross examination was concluded.

Chairman Burrows then inquired of the witness: "Is there any method by which the president of the Church may be deposed?"

"If he should engage in any un-Christian-like act that would injure him for his position, he would be deposed as any other member of the Church and if found guilty he may be removed."

HELD UP CHINAMAN. Crowd Started in Pursuit—Race Was Hot and Ended at Police Station.

On west Second South street about 10:30 o'clock Saturday night there was considerable excitement over an assault upon a Chinaman and an alleged attempt at robbery. JAP GIRL HELD. Judge Marshall Denied the Writ of Habeas Corpus Today.

Judge Marshall of the Federal court this morning denied the writ of habeas corpus, issued on behalf of the young Japanese, Hana Katada, and the girl will be returned to the custody of Immigration Agent Longley, to be taken to Port Townsend and from there deported to her native land.

In this case the accused was charged with being in this country for unlawful purposes. A fellow countryman, whom it is alleged was the means of bringing the girl here, will have a hearing before Judge Marshall this afternoon.

In the case of the State vs. George H. Nichols, charged with embezzlement from the Hiel Ice company, the action was dismissed by Judge Diehl this morning on motion of the prosecuting attorney, and the accused was discharged.

Judge Armstrong has ordered Dr. William St. John Downey to pay his wife, Josephine Louise Downey, \$25 per month temporary alimony pending the determination of the suit for divorce filed by her in the district court recently and also \$50 as attorney's fees.

PRINTERS' STRIKE HITS LEGISLATURE.

Trouble on in Union Shops Prevented Lawmakers Getting Bills Today.

TO SETTLE BY ARBITRATION. Demands Were Made That Employers Thought Were Unjust—Men to Go Back Pending Adjudication.

A printers' strike hit the Legislature today, and accordingly its work in the way of considering printed bills was temporarily interrupted.

It was ascertained that the press fitters employed in the Tribune job office, Daily Reporter, Western Newspaper Union, Gardner & Company, and the Century Printing company failed to put in an appearance at their respective places of employment this morning.

Such action was not unexpected in some of the offices, as intimations foreshadowing what was going to happen were dropped several times last week through the press.

The above named shops belong to the union. The non-union shops were of course not affected. The cause of the trouble seems to have been that the job press fitters would not agree to the new contract proposed by the union, and a fraction of the journeymen, or to the discharge of journeymen to make room for apprentices. The subject is one that has been before the Legislature for a considerable period.

No satisfactory settlement being arrived at, the strike was ordered on Saturday night and went into effect this morning.

Necessarily the shops aimed at were greatly embarrassed, as this is an exceedingly busy time of the year, every one of the shops attempting to do its best, and being unable to print to its capacity by reason of the increased work made necessary on account of the meeting of the Legislature.

The Tribune job printing office has the contract for printing the "open acts" or bills of the Legislature, and it was these that were not forthcoming at this afternoon's meeting of the law making body.

Fortunately the minutes which are being printed by the Deseret News, were not included, this establishment not being a union shop. Accordingly the record was delivered as usual.

It appears that there was no element of dissatisfaction in the strike over a demand for increased wages, as that subject was satisfactorily adjudicated some three or four months ago. It is claimed by the proprietors of the different shops that the strike was precipitated by agitators and that no possible good can arise as a result of the refusal to go to work this morning.

The subject was under consideration by all of the proprietors for the entire forenoon, and at 1 o'clock this afternoon the men returned to work pending the arbitration of the case. The work of the shops anticipates the settlement of the question tonight.

IN THE SENATE. Considerable Business Transacted by that Body Today.

It was committee day today with the state senators. Fresh from visits to their constituents, the law makers returned to the senate chamber surcharged with ideas for bills. The committee clerks were kept busy copying them for the satisfaction of many senators, who have been waiting most of the morning in drawing them up.

The bills did not come in with a rush when the senate opened as their authors want a little longer to think them over before presenting them to their colleagues. Tomorrow, however, a record breaking run of new bills is expected to commence.

Among those prepared for presentation are: a bill for the relief of Senator Holmgren, Clerk, Walton and Larsen. Senator Walton's measure deals with the state land board and is said to be in conflict with that of Senator Rasbary, which is already pending.

Considerable annoyance was occasioned to the senate members by the non-arrival of bills and memorials ordered printed Friday. It is stated that the messengers who went out to search for the missing printed matter that the firm engaged in the work was suffering from a strike of its employees and could not deliver the work.

The regular session of the committee appointed to investigate the deficit of the St. Louis exposition commission met for an hour.

Senate bill 22, providing for the purchase of the State Park (by reference) makes it a misdemeanor for anyone to be acted or to appear in an opera or a play without the consent of the owner of it. The committee will vote on the bill returning the senate bill on repealing the bounty law rejected. On motion of Senator Lawrence a conference committee of three was appointed to frame a new bounty law in connection with a like committee from the house.
