

### KING OF BEGGARS PLACED IN JAIL.

Alleged to Have Cleaned Up Tens of Thousands of Dollars in a Few Years.

### HE LIVED AT EXPENSIVE HOTELS

Maintains Home in Hoboken—Began His Operations as a Professor of Sanskrit at Leipzig.

New York, April 25.—Herman Wilhelm Troebner, "King of the Schnorrers," as a band of professional beggars is known, is locked up here awaiting arraignment on several complaints by the Charity organization society.

Officers of the latter allege that Troebner has cleaned up tens of thousands of dollars in the past four or five years and that the full list of persons from whom his unique methods procured money would read like a social register of New York. Troebner has lived at expensive hotels and for years has maintained a home in Hoboken for his wife and child. He is said to have lost large sums in gambling both here and in the west. Under arrest with him is his secretary, Otto Wittke, to whom he paid \$25 a week to attend to the clerical work of his business.

Troebner began his operations as a professor of Sanskrit from Heidelberg or Leipzig. University men, and especially professors, were much in his favor and his story generally was to the effect that remittances from home had failed to arrive leaving him temporarily in need of funds. In 1902, he was sentenced to six months' imprisonment for mendacity. In that case he used the name of Baron Von Mantouff. Recently he returned to New York and the Charity organization heard of him through the officials of a copper mining company to whom he represented himself as an expert mining engineer. Technical questions asked him placed him under suspicion because he failed to display much knowledge on the subject.

When arrested Troebner and his secretary were en route to Boston, whence they expected to sail for England.

### SUITS AGAINST MOYER.

Federation Leaders Believe They Are Retaliatory.

Denver, April 25.—President Charles H. Moyer, Secy. W. D. Haywood and other officers of the Western Federation of Miners, and Atty. John H. Murphy, the counsel for the federation, met in consultation today relative to the defense in the suits for heavy damages instituted by the Cripple Creek mine owners.

### IN TURKISH ARABIA.

Situation There Has Become Very Critical.

Aden, Arabia, April 25.—The situation in Turkish Arabia has become critical. It transpires that only a thousand of the Turkish troops sent to the relief of Riza Pasha reached Sanna, and these fled thither after sustaining a defeat at the hands of the insurgents.

Riza Pasha's troops, 6,000 strong, encountered the Arabs in great force five miles south of Sanna, March 24, and after a sharp encounter most of the troops, consisting of Syrian reserves, laid down their arms or deserted, the remainder of the Turks managing to reach Sanna the same evening with only 50 camel loads of supplies.

The chief of staff, Zinat Pasha, was killed and seven guns were abandoned and taken possession of by the Arabs, who also captured 200 camels laden with provisions and large quantities of rifles and ammunition.

The investment of Sanna by the insurgents is being tightened. The Syrian reinforcements which recently arrived at Arabia are unsatisfactory, and the Ottoman officials are anxiously awaiting the arrival of European battalions, upon whom the fate of the capital of Yemen province depends.

### GOVERNMENT HAS A RIGHT TO ACCEPT REBATES

Washington, April 25.—The attorney-general today sustained the secretary of the interior in his rebate agreements with railroads, in connection with the transportation of material for reclamation purposes.

The law which the attorney-general interprets as governing the case is contained in section 22 of the interstate commerce act. Its language is: "That nothing in this act shall apply to the carriage, storage or handling of property free, or at reduced rates, for the United States."

The attorney-general reaches this conclusion: "The intention of section 22 of the act to regulate commerce was to give express sanction to any arrangement between the United States, state or municipal governments and railroad companies by which these governments might relieve themselves of the cost of transportation in whatever form it might assume, and the section should be construed to give effect to that intention."

### INDUSTRIAL ORGANIZATION.

One Will be Formed in Chicago in June.

Butte, Mont., April 25.—Butte labor unions have received a circular letter from the American Labor union, announcing the resignation of Clarence Smith as secretary and treasurer. His successor is John Riordan, of British Columbia. Mr. Smith, in a signed letter, makes a strong plea for an industrial organization, which will be formed in Chicago in June by Dan McLaughlin of Montana, former president of the labor union, but who resigned a month ago.

### Rail Record is Broken.

Schenectady, N. Y., April 25.—The electric locomotive recently built for the New York Central service between Croton and New York, broke all its previous records today, by attaining a speed of 33 miles an hour, hauling a heavy train.

### Killed for Insubordination.

Moscow, April 25.—Disturbances occurred today at the Moscow Mazan station, when an Amisk regiment was en route for the front. A lieutenant with his revolver killed a soldier for insubordination.

## DR. GLADDEN PITT IN A PREJUDICEMENT

A Statement Authorized by Mr. Rockefeller Flatly Contradicts His Assertions.

### CHARGE OF PERJURY FALSE.

Declared to Rest Upon a Garbled Report—More Contributions Solicited.

New York, April 25.—Starr J. Murphy, of John D. Rockefeller's private counsel, today issued the following statement by Mr. Rockefeller's authority:

"In his latest attack upon Mr. Rockefeller, Dr. Washington Gladden seeks to make out a case of perjury, and in doing so assumes patently for a falsehood which has been frequently published during the past 10 years, and until now never answered. Dr. Gladden says:

"The South Improvement company was one of the schemes invented by the standard oil magnates to plunder the competitors and enrich themselves. The organization and the methods of this company were abundantly proved in court, and the company was driven out of business. A few years afterward, before a committee of the New York legislature, Mr. Rockefeller, under oath, took part in the following colloquy:

"You were not in it?"  
"I was not."

"Mr. Lloyd appropriately adds: 'So help me God.'"  
"On the same day another of the former trustees and one of the closest associates of Mr. Rockefeller, being asked by a congressional committee who made up that South Improvement company, named as its president, the principal members of the Standard Oil company, and at the head of all stood the name of John D. Rockefeller."

"Dr. Gladden makes much of his position as an original investigator, and says that it is within the power of every intelligent man to find out from the original documents whether the statement is true or not."

"But unfortunately his statement is untrue, and his whole charge of perjury rests upon a garbled report. The testimony is taken from a report of an investigation relative to trusts, in the New York senate, in 1888, pages 419-420. Any one turning to that report will find that Mr. Rockefeller's testimony to the effect that he was not a member of the company did not refer to the South Improvement company at all, but to another and entirely different corporation called the Southern Improvement company."

"There were two corporations—the South Improvement company and the Southern Improvement company. The Southern Improvement company was incorporated in Pennsylvania on April 16, 1870, and Mr. Rockefeller was not connected with it. The South Improvement company was incorporated in May, 1871, and Mr. Rockefeller was connected with it. The charters of both these companies are printed in full in the statutes of Pennsylvania, and are accessible to all."

"If Dr. Gladden garbled the testimony in order to make out a case there is nothing more to say. If he has done it ignorantly and has confused the names of these two corporations, he is scarcely less culpable, since when making a charge so serious a character it was obviously his duty to possess himself of the facts."

### ASKS ANOTHER CONTRIBUTION.

Boston, April 25.—The Journal of the American Missionary society, the Congregational body which is to meet here tomorrow, has recently asked John D. Rockefeller for a contribution of \$100,000 for home missions.

### FUNERAL OF SEN. PLATT.

Services Were of a Simple and Impressive Character.

Washington, Conn., April 25.—To attend the funeral of Senator O. H. Platt, regular and special trains brought hundreds of visitors to this village today, among them were members of the congress, senators and Vice President Fairbanks, who was present as the representative of President Roosevelt.

The Congressional church, where the services were held, was entirely too small for the crowd.

In keeping with the marked simplicity of all the funeral arrangements, the altar decorations consisted of the main branches of evergreens and mountain laurel, banking the altar rail.

Across the organ at the foot of the pulpit a large American flag was draped, and immediately above the music rack was a large wreath, sent in behalf of President Roosevelt. At the conclusion of the services Vice President Fairbanks, as the representative of the nation, was the first to pass out of the church, the members of the family, the national delegation and the other members following. The casket was placed in an evergreen wagon. The interment was in the village cemetery.

### Insurance Rates Raised.

New York, April 25.—An increase of 3 to 6 per cent in the premium rates for policies which do not confer upon their holders a right to participate in the dividends of the company has been put into effect by four of the largest life insurance companies in this country. The new rates of the different companies are essentially the same. On ordinary policies the increase over old rates is between 5 and 6 per cent. This is the largest increase. On limited payment life and endowment policies the advance is between 3 and 5 per cent, varying somewhat according to the age of the insured. The advance in rates follows a similar plan, made by holders of participating policies that the difference between the rates charged for a non-participating policy and those charged for a policy that participates in the profits of the company have in some instances amounted to more than the dividends paid to the participating policy holders.

### Soldiers Pillage Stores

Borissov, Government of Minsk, Russia, April 25.—Two thousand soldiers entraining here today for the front, pillaged the liquor stores and smashed the doors and windows of the baggage and Red Cross cars.

### Attorney General of Porto Rico.

Washington, April 25.—Frank Fusile has been appointed attorney-general of Porto Rico, vice Stewart, resigned. He is from Texas and has been in Porto Rico ever since the American occupation and at one time was assistant attorney-general there.
