

PERJURER TANNER GIVEN A PARDON

Committed the Offense to Shield His Partner, Late U. S. Senator John H. Mitchell.

HE WAS NEVER SENTENCED.

His Excess Was Mitchell Had Given Him His Start in Law Business.

Portland, Or., July 5.—Judge A. H. Tanner, who committed perjury in order to shield his law partner, the late United States Senator John H. Mitchell, was pardoned by the president June 28.

The announcement was made by Asst. Atty. Gen. Francis J. Heney today. Judge Tanner was convicted on his own confession that he had perjured himself before the federal grand jury in testifying that the partnership agreement of the firm of Mitchell & Tanner had been in existence several years, whereas it was less than three months old.

This agreement affected the division of attorneys' fees received for practice before any of the departments of the federal government should belong exclusively to Tanner.

It was upon this agreement that Senator Mitchell intended to base his defense that he had received no money for practice before any of the departments of the federal government.

Judge Tanner's confession was by far the most sensational feature of the land fraud trials in this state, not even excepting Mitchell's indictment. Judge Tanner had been considered a man of unimpaired reputation and his confession came as a clap of thunder from a clear sky.

In an interview given to the Associated Press at the time, he said that he had confessed in order to save his son, who was a clerk in the law office of Mitchell & Tanner, and who had drawn up the contract, from going to prison. He excused his conduct in perjuring himself by saying that he had been on intimate terms with Mr. Mitchell since boyhood, and that it had been Mitchell who first gave him his start in the law business, not to mention his having been Mitchell's partner for more than a decade.

Judge Tanner was sympathized with by people here generally, where Senator Mitchell's wonderful hold on his friends was best known. Judge Tanner was never sentenced, as it was generally understood that the government would allow him immunity in consideration of the service he rendered it, when he later went on the witness stand during Mitchell's trial in the government's behalf.

ANARCHIST ROSENBERG ONLY A PAINT MIXER.

Seattle, Wash., July 6.—The central committee of the United German Societies of Seattle came to the front at its regular meeting tonight and declared that August Rosenberg, arrested in Germany, upon suspicion of being an anarchist with designs against the life of Emperor Wilhelm, was nothing but a harmless mixer of paints.

The letter which caused the arrest of Rosenberg, the members of the committee, having known Rosenberg for several years, states that Rosenberg

was an inventor and investigator of paint compounds, and that the chemicals and apparatus found in Rosenberg's old shop were all for the purpose of experimentation in this line. Most of the supplies in his researches were purchased from Nello & Englebrecht and Dr. Warmburg, a chemist, was often called into consultation by Rosenberg touching his experiments. The books on chemistry, Rosenberg purchased at Rheinlander's book store here.

According to this committee man, Rosenberg was 72 years old, had amassed about \$8,000, a competency for himself and wife and his return to Germany was to spend the rest of his days in ease.

MRS. HAYES SENTENCED.

Was Convicted of Stealing a Diamond Worth \$300.

Omaha, Neb., July 6.—Mrs. Mae Hayes, convicted of a theft from a local jewelry firm of a \$300 diamond, which she is alleged to have swallowed, was today sentenced to five years in the penitentiary by Judge Sutton in the district court. Mrs. Hayes was looking at unset gems in the jewelry store and when the clerk's back was turned she put a large stone in her mouth. Two detectives who had been shadowing her at once arrested her, and she claims it was her fright that made her swallow the diamond. The gem has never been recovered, although Mrs. Hayes offered to submit to a surgical operation if prosecution was dropped. This the state would not agree to.

BOGUS UNION CARDS.

Searching Inquiry Being Made Into Their Issue in New York.

New York, July 7.—Asst. Atty. Murphy had before him 30 witnesses yesterday, whom he examined closely in reference to the charge of larceny against Samuel Platt, secretary of local No. 52 of the Housewives & Bridge-men's union. Platt was held Thursday by a police magistrate on complaint of Lewis Miller, who alleged that he had paid \$150 to Platt for a union card and its accompanying membership in the union, which had afterward turned out to be bogus, in that it had not been authorized by the union. Platt's examination was set for next Monday. It is said that the district attorney's office is convinced that there was a plot by some one to issue bogus cards to unsuspecting workmen for the personal profit of those engaged in the plot. Altogether the men in the scheme are said to have issued over 50 of the cards and to have made away with something like \$5,000.

HUGHES GOING TO EUROPE.

New York, July 7.—Charles E. Hughes who was chief counsel for the Armstrong legislative investigation committee, will sail for Europe today on the Clarendon line, accompanied by his son, Mr. Hughes is badly in need of rest. He has had no relaxation whatever since last August, when he began his preparations for the insurance investigation. Immediately after drawing up the report of the Armstrong committee to the legislature he was retained by the federal government to prosecute officials of coal roads for alleged violation of the interstate commerce law.

This work has been most exacting and coming directly after the insurance investigation has put Mr. Hughes in a condition where a let-up is imperative. Mr. Hughes is building up the various coal road cases with extreme care. He will not be in a position to take any public move in the matter until well along in the fall.

CONFESSION ON THE GALLOWS.

Wilmington, N. C., July 6.—Before suffering the death penalty on the gallows today for the murder of white men, members of a crew of a small schooner, Henry Scott, a negro, admitted his guilt and declared that two other negroes convicted with him are innocent.

On the strength of this confession, President Roosevelt will be asked to pardon the other negroes, Arthur Adams and Robert Sawyer, who are under sentence of death.

SOCIALISTS ARE FOR HAYWOOD

Party Convention in Denver Names Him for Governor Of Colorado.

IS NOW IN PRISON IN IDAHO.

Man Who Named Him Proposes to March to Caldwell and Release Him.

Denver, Colo., July 6.—It just transpires that the Socialist party of Colorado had a convention in this city on the Fourth of July and nominated a full state ticket, headed by William D. Haywood, secretary-treasurer of the Western Federation of Miners, now in prison in Idaho, for governor. The balance of the ticket follows: Secretary of State—H. C. Darrab, Colorado Springs. Treasurer—J. W. Sawyer, Grand Junction. Auditor—John M. Martin, Denver. Attorney-General—A. H. Floagin, Denver. Superintendent of Public Instruction—A. L. Lurch, Wellington. Regents of State University—Dr. J. H. Morrow, Denver; Dr. E. H. Graeb, Denver. Judges of the Supreme Court—F. Woodside, Colorado Springs; John M. King, Denver. Congressman-at-Large—Guy E. Miller, Telluride.

In nominating Haywood, John M. Martin of Denver said: "I do not rise to name a well-groomed business man or a professional politician, seeking graft. Nor do I name a labor leader who is dined and wined at Civic Federation banquets. But I rise to name a man who, in executive ability, is the peer of the best, and whose personal integrity is without stain; a man whose hands have been calloused by honest labor and whose every heart throb is in sympathy with those who toil; a man who has never been praised by the capitalist press as the greatest labor leader in the world, but one who as a labor leader has never betrayed his trust nor sold out a strike; a man who, because of his loyalty to the working class, has been struck down by a brutal soldier on the streets of our city, and who, for that same loyalty, was kidnapped by tallies and, contrary to all legal forms and observances, was carried to a distant state and thrown into a felon's cell, where for months he and his faithful comrades have waited, demanding in vain the speedy trial guaranteed to every citizen by our Constitution and laws. William D. Haywood, the prisoner in Caldwell jail."

Mr. Martin declared that the working classes of Colorado would rally to Haywood, and that he would be elected. Concluding, he said: "And if they refuse to release him we may feel impelled to march to Idaho and take our chief executive by force, if necessary, out of the teeth of the dogs of capitalism, and carry him in triumph to our state house."

HELD UP BARTENDER.

Lone Highwayman Got \$50 From Warm Springs Saloon.

A burglar held up the bartender and robbed the Warm Springs saloon at an early hour this morning. Harry Druce, the bartender, was alone at the time, and was ordered by the highwayman to hold up his hands. As the latter held an ugly looking pistol, the order was instantly obeyed. The thief took from the till \$50 in cash and a \$10 check, and departed through a side door. Mr. Druce telephoned to the police, but Officers George Phillips and George Moore, who responded, could find no trace of the robber. The holdup is described as being about five feet four and a half inches tall, of rather heavy build and of dark complexion. He wore a slouch hat and a blue handkerchief covered most of his face. The check bore the signature of A. B. Margetts and was drawn upon the bank of W. S. McCormick & Co.

Then Miller came into the affray, and he was knocked down repeatedly by blows from Cesar's weapon. The fight was still in progress when the police, who had been summoned, appeared upon the scene. Officers Busa, Kelley and Taylor answered the call and took the three men to police headquarters. It was found that May had been struck on the back of the neck, the blow cutting a long and deep gash. Miller had a dozen wounds on the head, and it required 35 stitches at the hands of City Physician Stewart to close the wounds. May showed no serious attention. Miller and May were locked up and Cesar was later released on a \$100 bond.

SHUT YOUR MOUTH; ADMIT FRESH AIR

The Rules for Breathing and Ventilation Given at the University.

FOUL AIR IS RANK POISON.

Devices for Letting Pure Atmosphere Into Vitrated School Rooms and Other Buildings.

The nature study lesson at the university yesterday consisted of a demonstration of the necessity for proper ventilation, for deep breathing, and for open-air exercise for growing children.

EXPERIMENTS IN BREATHING.

Some of the evils of impure air are that it makes the children drowsy, gives them a headache, and adversely affects their general vitality. The general subject of ventilation was introduced by means of two simple experiments: the class timed themselves in breathing for one minute, and it was shown that the average number of respirations per minute was 18; and by means of breathing through a tube into a three-quarter bottle filled with water and the mouth inverted in a vessel of water, that an ordinary breath expels one quart of water. It follows that a person breathes 18 quarts, or about 1,639 cubic inches of air per minute. Other experiments showed that air once breathed was put out a lighted candle, and since life is a process of combustion, air that has been breathed may extinguish the lamp of life.

RULES FOR BREATHING.

From these experiments the laws of breathing were easily deducible. 1. Breathe through the nostrils. Habitual mouth breathing shrinks the gums, causes the teeth to protrude, draws lines in the face, subjects the system to disease and is a serious menace to health. 2. Breathe deeply. The lower chest and broader part of the lungs should be brought into play in the work of respiration. Breathing should not be confined to the chest but the abdominal muscles should participate in aiding the habit of receiving deep and full drafts of fresh air into the lungs. 3. Take very deep breaths in the open air several times daily. 4. Provide means for ventilating all rooms, particularly sleeping rooms and school rooms. There should be an entrance for the fresh air preferably under the door, and an open ventilating flue, or an open grate or open stove, in every school room or meeting room. The lesson closed by the class making an inspection, under the professor's direction, of the university heating plant, including the devices for securing good ventilation in the classrooms and laboratories.

ONE OF MORGAN'S RECOLLECTIONS.

While a group of senators were sitting in the room of the committee on intercommerce canals, Senator Morgan grew impatient and told about his early experience in the senate. Alabama, he said, was represented in the senate after the Civil war by "carpetbaggers," and he was one of the first to defeat that element. At that time he had as a colleague Senator Spencer, who with Roscoe Conkling "cooked a deal" to unseat Morgan without making a report or giving the subject any consideration. Conkling wrote a speech and Spencer delivered it, pointing out that Morgan was not legally elected. It was quite a bitter speech and at its conclusion a vote was taken. Every senator voted for Morgan except Spencer, not even Conkling standing by the "deal."

SPENCER'S ENERGETIC CAREER.

Some one who knew Spencer recalled that he was sutler in a Union regiment in the Civil war, and Morgan said that he held the same position in an Alabama regiment. His last notable appearance was at Bismarck, N. D., when he appeared with a scheme to establish a lottery in that state. The famous Louisiana lottery was about to be driven out of the Pelican State and it was looking for a place to operate. Spencer went to North Dakota and almost succeeded in establishing a great lottery organization in that state, but public opinion defeated it when the people found out what was proposed.

MIDNIGHT WANDERERS.

One evening not long ago Senator Penrose of Pennsylvania and Senator Carter of Montana made a trip in an automobile to Great Falls, about 14 miles above the city. On their return they had proceeded about three miles when the machine broke down. All efforts to fix it were unavailing, and the two senators started to walk, and an idea of catching a car or stopping at a suburban resort seven miles out. But the cars had stopped running and they could not obtain accommodations so they walked the entire 14 miles. There had been a great deal of rain, the roads were bad, the dogs particularly vicious and with no respect for material trousers or legs. Altogether it was a long and disagreeable tramp, and the next time these senators go out in an auto they intend to have a repair wagon accompany it.
