

CALHOUN'S CASE GETS INTERESTING

Detective Burns, Armed With Search Warrant, Breaks Into Office and Seizes...

WAS SEARCHING FOR PAPERS

Employee of Burns Breaks Down, Confesses and Tells of Working for the Defense.

San Francisco, March 28.—Following the sensational developments in the bribery-graft cases yesterday, brought about by the arrest of three United Railroad officials and five other persons in connection with the alleged theft of jury lists, data concerning various men and similar papers from the office of the district attorney and that of William J. Burns, who heads the detective force of the prosecution, Frank J. Murphy, associate counsel for Abraham Ruef during the trial of the former political boss, was taken into custody today.

The others arrested are William A. Abbott, assistant general counsel for the United Railroads, Joseph H. Handlon, claim agent for the railroad; Luther Brown, head of the railroad detective; Rex N. Hamlin, private secretary to William J. Burns; Al McKinley, declared to be a confidential employee of the railroad; William Corbin, said to be a former agent for Rufus Jeremiah Van Wormer, a railroad detective, and E. A. Platt, who is attached to the district attorney's office.

Abbott and Murphy are charged with having received stolen goods, and all the others with grand larceny. Handlon, Brown, Abbott and Murphy have been released on bail provided by an agent of the railroad company.

From late last night until early this morning the offices of Patrick Calhoun and his legal staff in the Balboa building were in charge of Burns' men, who were armed with a search warrant issued by Police Judge Deasy. The search of the rooms was begun after their occupants had fled. Handlon, who in the defense of Calhoun, had refused the detectives admission and the glass door had been broken in. The work of looking over every paper found in the several rooms was finished tonight after two safes filled with Calhoun's personal papers, and another used by Thornwell Mulloy, had been forced open by an expert called in by the officers. The search was watched by Calhoun in person today on his return from Glenn county, where he spent Saturday in a hunting trip.

BURNS' STATEMENT

According to the statement made by Burns, he had suspected that some one in his employ was receiving money from the defense in the Calhoun case and other cases arising out of the bribery charge in connection with the overhead trolley franchise. Burns said that he finally became convinced that Hamlin, his secretary, had been approached in a roundabout way, and he was in receipt of \$200 a month from these persons, for which he had been systematically betraying the secrets of the prosecution to the defense.

Having satisfied himself as to these, Burns placed Hamlin, McKinley, Corbin, Van Wormer and Platt under arrest. He states that Hamlin, Corbin and Platt confessed, and he secured search warrants, by virtue of which his men entered the railroad offices and Luther Brown's office and went through all papers they found. The arrest of Abbott, Brown, Handlon and Murphy followed, and they were held on bail as soon as they arrived at the police station.

"Documents found in Calhoun's office fully justify our proceedings," said Detective Burns tonight. "We were looking for copies of our records and papers in connection with the various cases, and found what we sought. The confessions and the papers we found are convincing evidence of the bribery of my men by the Calhoun interests."

CALHOUN'S STATEMENT

Mr. Calhoun made a statement to newspaper men tonight, in which he said: "You have been, gentlemen, witnesses of one of the most significant outrages ever committed on the American continent. Under our Constitution and as a part of the fundamental basis of American liberty, every man is protected against the unlawful search and seizure of his papers.

"Yesterday afternoon was a legal holiday. I was absent from the city. William J. Burns took this opportunity, by swearing out a bogus complaint, to seize upon the offices of the United Railroads and make a search of its papers and records."

Calling attention to the fact that he had protested a number of times against looking at papers which from their headings bore evidence that they could never have been in possession of Burns and that one of the searchers replied that they were looking for a signature to a telegram, Calhoun continued: "This could not under any stretch of law have been within the purview of a search warrant made avowedly for the purpose of securing papers belonging to Burns. The evident purpose of this search warrant was not to obtain papers belonging to Burns. It was a fishing expedition for the purpose of looking into the private affairs of the United Railroads and, if possible, gathering from their files some evidence to support their alleged charges of bribery against me."

"This search and the manner of its conduct is a fitting climax to the course which the prosecution has pursued toward me."

CALHOUN'S SUITE SEARCHED

San Francisco, March 27.—Armed with a search warrant and backed by a dozen special officers, 10 or more police detectives and a score of patrolmen, headed by Detective Sergeant Thomas Murphy and Asst. Dist. Atty. Thomas Tarrison, broke into the office of Patrick Calhoun, president of the United Railroads, late tonight and searched every book and cranny in the suite which is occupied by Calhoun and the legal forces of the company. ENTIRELY NEW TYPE OF AUTOMOBILE

A motor car of an entirely new type so far as the body lines are concerned has just been shipped to Europe for the use of George K. Birge of Chicago. It is a six-cylinder 90 horsepower Pierce-Arrow, the chassis of which is fitted with a 185-pound body. As the standard bodies of the size used on Mr. Birge's car are made for cars of much less horsepower and consequently heavier when bases there was considerable space left between the back of the body and the rear of the frame. This has been filled for the attachment of a large permanent baggage boot, suggestive of that of the old English and our own plated stage coaches. This boot has ample room to hold three good sized trunks. The main color of the car is chrome yellow, relieved by black stripes following the lines of the moulding.
