HEAVY DAMAGES AGAIN AWARDED

Jury in Hudson Avenue Condemnation Suit Allows Sorenson Large Sum.
Ogden, Nov. 23.—After considering the evidence for less than 20 minutes, the jury in the case of Ogden city against Carl Sorenson returned a verdict awarding Sorenson judgment for \$2,745 for three feet of land taken to complete the Hudson avenue opening Twenty-fifth street, and damages in the sum of \$745 for the balance of the property. Sorenson sought to recover \$3,000 for the property and \$2,200 damages. There are now very few cases to settle before the condemnation proceedings brought by the city are disposed of. Judge T. D. Lewis is on the bench and it is probable that all of the Hudson avenue litigation will be cleared up by the end of the week.

SUIT TO RECOVER ON PROMISSORY NOTE

Ogden, Nov. 23.—To recover \$1,860 alleged to be due on a promissory note, the Rocky Mountain Stud Farm company has started action in the district court against M. S. Truman, John W. Drasher, W. H. Leonard, J. P. Brockbank and E. C. Gray. The defendants are alleged to have purchased a Clydesdale stallion named "Times Gun" for the plaintiff on Nov. 22, 1907, for the sum of \$3,600, a portion having been paid in cash and the balance was paid by notes signed by the defendants.

DISSATISFIED PARTNER ASKS FOR DISSOLUTION

Ogden, Nov. 23.—Asking for dissolution of partnership, for a receiver and a restraining order to keep James Cotton from making further collections for the firm, W. Wright of Ogden has started action in the district court against Cotton, of San Francisco. The complaint alleges that on June 15, 1910, a partnership was effected between the parties, and that under the firm name of the "Sunset Live Stock Commission company," the agreement being that both parties should share alike the losses and profits of the business. Wright claims that Cotton has taken considerably more than his share of the proceeds of the business, a sum of about \$3,000, which he is informed Cotton has deposited in his personal account at the Security Trust & Savings bank of Ogden. Plaintiff further maintains that his partner continues to collect and appropriate funds of the company to his own private use. The court has granted the request regarding a receiver and has appointed T. D. Ryan to act in that capacity. Cotton is also restrained from further interference in the affairs of the firm until a full accounting of the business has been made.

RECALCITRANT HUSBAND CITED FOR CONTEMPT

Ogden, Nov. 23.—Judge T. D. Lewis has issued an order directing Le Roy Stone to appear in his district court on Nov. 28, and show cause why he should not be punished for contempt of court for failing to pay into the court the sum of \$250 per week, as attorney fees in the divorce case of Hildred Stone against Le Roy Stone. The total amount to be paid is \$25.

Santaquin Assault Case Therefore Still Remains an Unsolved Mystery.

Provo, Nov. 23.—The charge of assault with a deadly weapon, with intent to do bodily harm, against two Santaquin young men, David Greenhoush and Brigham Peterson, is now probably closed. The defendants had a hearing yesterday before Justice Joseph Nelson at Santaquin and were discharged, the justice holding that there was not sufficient evidence to justify holding them. They were charged with assaulting Mosiah Gauderson of Santaquin.

Provo, Nov. 23.—Otis L. Terry of Provo Bench sent some Utah apples to the Brother Jonathan show conducted at St. Joseph, Mo., under the auspices of The Fruit Grower. He has received a complimentary letter on the superior fruit sent from E. H. Farr of The Fruit Grower. Among other things, Mr. Farr says: "We are glad you included the Mann and Delaware Winter Reds, as these are the best of your kind and put you in a better position for the general prize display. EXCELLENT PROGRESS MADE BY ACADEMY

Raymond, Canada, Nov. 15.—The stake academy here is making gratifying progress. The gymnasium will be one of the school's special features and will be opened in the near future awaiting only the arrival of the apparatus and the putting down of a new floor. It is necessary to equip the gym, which was apportioned to the stake improvement associations, has been raised, and is now available. A dramatic entertainment given during conference materially assisted in supplying the funds. The library will be given permanent quarters in one of the finest rooms in the building and already a nucleus of 20 volumes has been supplied.

Recently Supt. Horace Cummings, accompanied by President H. S. Allen, of this stake, and President Ed. J. Wood of the Alberta stake, visited the provincial educational authorities at Edmonton and were shown every courtesy during their stay. The purpose of the visit was to establish the academy on a recognized governmental basis, and the mission was eminently successful.




