THE DEBATE RESUMED.

Senator Aldrich Presents Two Tariff Bill Amendments.

RECIPROCIITY PROVIDED FOR.

Eleven Pages of the Document Disposed of Yesterday.

A Compromise Measure Agreed Upon by Conferees on the Land Grant Forfeiture Bill—House Land Bill in the Senate and Referred.

WASHINGTON CITY, Aug. 28.—In the Senate the resolution providing for the suspension of work on the Lafayette statue is amended to provide for the selection of another site and architect.

Reagan today introduced a substitute for his amendment to the tariff bill proposing reciprocity arrangements with Canada and Mexico for free manufactured articles and mineral products. The substitute included agricultural products, such as wheat, corn, and other cereals, and also provided for the free introduction of such sugar, molasses, coffee, tea and hides, the products of any country for such items as he shall deem just, and in such case and duty as such suspension of the duties shall be levied, collected and paid upon sugar, molasses, coffee, tea and hides, and other such designated country as follows:

On coffee 2 cents per pound, and for every additional degree of fraction shown by polariscope test, 2-100 of 1 cent a pound. On tea 10 cents per pound. On hides, raw or uncurd, whether dry, salted or pickled, Angola goat skins, raw without wool, manufactured cases of any material, unmanufactured, and other skins, except sheepskins with wool, 15 cents per pound.

The Washington delegation favors the appointment of one man on each commission from their state. The law allows this. The positions are of great responsibility and trust. The compensation is \$10 a day. It is understood that the names of two well-known Washington citizens were submitted to the secretary, but all concerned refused to make them public until after a conference with the president.

A platform was adopted denouncing Dudley and alleging that Harrison and Morton carried the state in 1888 by fraud; it says the electoral vote of Indiana was obtained for Harrison and Morton by the most flagrant crime against the ballot-box ever perpetrated in an American commonwealth; that these crimes were committed under the direct auspices of William Wade Dudley, then and now treasurer of the national Republican committee, by the procurement and connivance of the Republican leaders in this state; that the national administration of Benjamin Harrison has made itself an accessory after the fact to those crimes by shielding the criminal from punishment, and even by rewarding them with office and honor; and that the brazen prostitution of the machinery of the official court for the district of Indiana by its judge and attorney to the service and the protection of the conspirators against suffrage, constitute the most infamous chapter in the judicial annals of the republic. The platform continues:

We denounce the tariff monopolists for their efforts to perpetuate themselves in power by measures inconsistent with free institutions and good morals; we find in the force bill a bill creating rotten boroughs out of states, and in the McKinley tariff bill the open manifestation of a gigantic conspiracy of the minority to oppress a growing people with additional burdens of taxation for private benefit. We denounce the silver bill, so-called, recently enacted, as an ignominious surrender to the money power. It perpetuates the demoralization of silver and the single gold standard, whereas the interests of the people require the complete restoration of silver to a perfect equality with gold. In the present we demand the free and unrestricted coinage of silver upon the basis existing prior to 1873.
