Thomas King, who has served several terms on the chain-gang for vagrancy, was again arrested yesterday. This time he stole an overcoat from Washington street clothing store, and was arraigned in the police court, charged with petty larceny.

King was given the full benefit of the law—thirty days in jail and a fine of \$100, which is equal to eighty days in jail.

King has only been out of jail three days. A week ago he assaulted Jailer Evans at the city jail, and the dark rim which still lingers under the lash of the jailer's eyes shows where King planted his fists.

King was arrested yesterday by Officer Cave, and he fought, and when storming all the way to the jail, when he reached the corner of South Third street and Yelder street, he leaped a blow at Officer Cave's head.

Cave dropped the overcoat, which was hanging on his arm, and dodging the blow, whipped out his "billy" and belabored King over the head. King did not give up until he was covered with blood and almost senseless.

He then allowed himself to be walked to jail, although he still cursed and screamed. At headquarters he again freshened up, wanted to fight, but a liberal use of the "hook" kept him quiet.

After he had been searched Jailer Evans led him below. King remembered his previous run with the colored jailer and also how he had taken off his head in a punch in the short ribs.

Once in the cell he wheeled and attempted to knock the jailer out. Evans was prepared for him, and with a sound of whacks on the head and a display of arms and legs lying around.

When the officers on reserve came lying down to see what the fuss was about they found Evans calmly closing the cell door, while King was lying with torn clothes and bruised head inside the cell.

LITIGANTS AND CRIMINALS. Another Highway Robber Gets Justice—Oscar Erikson Seeks to Creep Out of a Bad Trade.

The saloon theaters are determined to fight the \$1,000 license provided for by city ordinance, and yesterday two restraining orders were gotten out to prevent the city and chief of police from interfering with certain saloons or their theaters.

One order was issued at the instance of Watkins & Considine, proprietors of a saloon and theater attachment at the corner of South Third and Washington streets, and the other at the instance of Kaid & Watkins, proprietors of the Elite theater and saloon on Jackson street.

In both complaints it is alleged that the proprietors have paid their liquor license and have offered to pay \$100 extra for their theaters, which is the regular theater license.

It is claimed that the ordinance taxing them \$1,000 is illegal and void because it discriminates against a certain class of trade.

They say that unless restrained the city will have its police abate their theaters, close their houses, prevent them from carrying on their business and will do them an irreparable injury.

Judge Osborn issued temporary restraining orders in each case to prevent the collection of the \$1,000 license and any interference with these places by the police authorities until the case is finally disposed of at a hearing set for January 30.

ERIKSON'S BAD BAIGAIN. He Charges Fraud and Sues to Recover His Lot.

Oscar Erikson and others brought suit in the superior court yesterday against W. C. Quinn for the recovery of lot 12 in block C. Quinn for the recovery of lot 12 in block C.

The complaint Erikson states that this lot is worth \$6,000 and has a mortgage on it for \$2,000; that C. B. Walworth, as agent for Quinn, proposed to exchange for this property a thirty-acre tract of bottom land in White river valley, which he claimed was free of incumbrance and was worth \$200 an acre.

and as regarded the representations, after looking at a tract of land purported to be the thirty acres contracted for, Erikson agreed to the trade and the transfers were made.

He says that he has since discovered that the property shown him by Walworth is not the thirty acres for which he bargained, but only part of this thirty acres is bottom land, the rest of it being a worthless hillside and the whole property is only worth about \$1,800.

There is a \$1,000 mortgage on the property and Erikson is held for March 1, 1890, and he could not get possession before March 1, 1890.

He asks that the deed be made to Quinn for the property he wanted and an aside for the reason that it was obtained by fraud.

Schoolmaster Stafford interfered and returned the knives to their proper owners, but after school the trouble was revived. A crowd of the boys chased young Sanborn to his home, where he turned on them, and seizing a stick struck twice at the first one he came to.

The boy who received the blows happened to be James King, and he was knocked senseless and an ugly scamp wound inflicted. The injured boy is now under Dr. Johnson's care.

It is expected that young Sanborn will be brought before Justice Anderson today on a charge of assault and battery. He is the son of one of the prominent citizens of Ballard.
