Washington City, Feb. 21.-The house devoted most of the day to the consideration of the senate amendment to the consular and diplomatic appropriation bill appropriating \$500,000 for the construction of a cable to the Hawaiian islands.

Storer deprecated making this matter a party question, but he said he realized that it was only in this way that the chairman of the committee on foreign affairs hoped to defeat this project.

Draper, Rep., Massachusetts, said he favored this cable as a preliminary step toward the annexation of the Hawaiian islands.

Herrmann, Rep., Or., declared that to the Pacific coast the question of a cable connection with Honolulu overshadowed and transcended all others, save only that of the construction of the Nicaragua canal.

Hunter, Dem., O., thought this cable should be laid by private capital, and he concluded, private parties had appeared before the committee and asked for a charter for this purpose.

Ryan, Dem., thought this Democratic house could well afford in the closing hours of the session to show its sympathy with merchants desiring to extend our trade by voting an appropriation for the construction of this cable.

Stokes, Dem., earnestly supported the cable proposition, but he was compelled to appeal from the judgment of the house committee on foreign affairs to that of the senate committee.
