County Will Pay Bounty Only on Mountain Lions.

TWO BIG JUDGMENTS GIVEN.

Chinfield Pleads Not Guilty of Burglary—Jolliffe Will Appeal His Cow Case—Court Notes.

Auditor Boman, as purchasing agent of the county commissioners, has issued a notice that after April 20 no bounties will be paid for the scalps of wild cats or foxes, and that the only bounty to be paid will be for scalps of cougars, panthers or mountain lions, which remains at \$100.

FRANK LOSES THE CASE.

John and Others Entitled to Judgment Exceeding \$82,000. In the case of Thomas Deas Boyd, Francis Archibald Brown, Douglas and David Paulin vs. John and Abbie Frink, James and Annie Redman and F. L. Fehren, Judge Langley yesterday signed findings of fact and conclusions of law. The action was adjudged dismissed as to Fehren.

Judgment in Favor of Schwabacher. The decree in the case of Sigmund Schwabacher vs. George M. Van Doren was filed in the superior court yesterday. It provides that the plaintiff recover from Van Doren \$11,629.95, and that a mortgage be foreclosed on the following property: Lots 3 and 4 and the west one-half of the southeast quarter of section 15, and lots 3 and 4 of section 15, township 2 north, range 4 east; also a tract of nine-tenths of an acre on San Grand's private road along White river.

Died While Visiting in the East. Percival B. Morton yesterday petitioned the probate court for letters of administration of the estate of Mina Belle Morton, an adopted daughter, who died, aged 12, in Brooklyn, N. Y., March 7, while on a visit to her natural father and sisters, whose name is Lusk. The estate is valued at \$50, and consists of two lots in Washington addition, four lots in Green Lake Circle railroad addition, and acres 1, 2, 3, 4 and 5, tract N, Maple Leaf addition to Green Lake Circle, all of which was devised to her by her adopted mother, Jennie D. Morton.

Cow Case Going to Supreme Court. A notice of appeal to the supreme court has been entered in the case of N. T. Jolliffe vs. the Seattle, Lake Shore & Eastern Railway Company, an action for damages for the killing of a cow. The case was decided by Judge Osborn, March 23, adversely to Jolliffe. The cow was a Holstein thoroughbred, valued at \$5. The owner sued for double damages.

The Receiver Wins. The suit of Thomas B. Hardin, as receiver of the Farmers' Insurance Company vs. E. F. Sweeney and H. D. K. Haderfeldt, was decided yesterday in favor of the receiver. There were three causes of action on promissory notes, aggregating \$1,586.

Chinfielder Pleads Not Guilty. Frank Chinfielder, the Kent horse thief, who was released only to repeat his offense, was arraigned on a charge of burglary in Judge Humes' court yesterday. He pleaded not guilty, and his trial was set for Wednesday, April 24.

What We Have a Navy For. Portland, April 13.—Special.—Lieut. Commander A. V. Wadhams, U. S. N., lectured last night to a large and appreciative audience at the Calvary Presbyterian church, corner of Eleventh and Clay streets, on "Life on Board a Man-of-War." He described in most interesting and thrilling manner the life and adventures of the seafaring defenders of the United States, experiences in foreign ports, the incidents during the conquest of Egypt by the English, the bombardment of Alexandria. He concluded by saying: "To give the country a guarantee of peace—that is all we have a navy for."

On a Regular Inspection Tour—Masonry of Stamped Tunnel. Receiver Oakes, of the Northern Pacific railroad has not yet arrived in the city, but yesterday afternoon General Manager Kendrick, Traffic Manager Hammond, and First Assistant General Freight Agent Fulton arrived and joined Chief Engineer McHenry, who came over Friday morning. During their visit in the city General Agent Nadeau took them in charge and they were for some hours guests at the Rainier Club. The officials said that their visit was merely for inspection, that they were out looking over the line and taking in the principal points along it. Mr. Oakes would have come over yesterday, but being indisposed, he remained in Tacoma. He will come to Seattle before returning East. Mr. McHenry spent half an hour with Gen. John H. Bryant, one of the receivers of the Seattle, Lake Shore & Eastern railroad. Mr. Kendrick made special inquiry as to the satisfaction of the new time schedule was giving to patrons here and said that they had but one late train so far as the eastern end. He says that the receivers will complete the masonry of the Stamped tunnel this summer and that the masonry of the Mullen tunnel will be completed in about two months. The side walls of the Stamped tunnel are already in and the work to be done is above the angles. The officials returned to Tacoma last night.
