THE CRAIG HOMESTEAD. Court Decides That It Was Not Subject to Community Judgment. Special Judge John E. Humphries yesterday rendered a decision in the case of Charles Craig and Anna Craig, against Thomas McDonough and J. H. Woolery, as sheriff, in favor of the plaintiff. The action was brought to enjoin the sale of a parcel of real estate under execution. Two causes of action were alleged, that as sheriff, James H. Woolery levied upon the separate and individual property of Anna Craig and that the property levied upon consisted of a homestead. The court held that the property came to Mrs. Craig as the result of her own earnings, accumulated by her labor and skill, and further, that the property had been transferred to her years before the debt of defendant was contracted. The contract between Craig and his wife, that she should have her earnings as her own separate property was valid, and took the property and earnings out from the community.

THE WOMAN TOO FRISKY. Why D. B. Denton Refuses to Marry Hannah Pease. D. B. Denton, defendant in the \$20,000 breach of promise suit, filed his answer yesterday, stating that since October 20, 1890, the plaintiff has been criminally intimate with several men, that he was not cognizant of her unchastity until recently and that when he discovered it he at once refused and still refuses to marry her. As an additional defense he states that the cause of action has not begun within three years immediately before the commencement of the suit, and therefore is barred by statute.

NOW THE CUT BEGINS. Reduction of Salaries Under Recent Action in Effect Yesterday. From June 1 the employees of the county work for salaries under the reduced schedule adopted some time ago by the county commissioners. The cut affected 25 deputies throughout the offices, with only a few exceptions, and amounted to considerable, in many cases being as high as \$3 per month. A majority of the deputies were scaled down \$3 each, while the remainder escaped with a reduction of only \$1.
