Japanese Woman Escapes the Deportation Law.

DISSOLUTE FULLY PROTECTED.

Conductor Wants Damages for Being Accused of Knocking Down—Yester Sale May Go On.

By a ruling of the commissioner general of immigration the doors of the United States have been thrown wide open to the Japanese women sent here undoubtedly for immoral purposes.

The case is that of Fuku Moto, a Japanese woman, who for several days past has been in custody on charges being made against her for immoral purposes.

In the opinion of District Attorney William H. Brinker, if the ruling of the commissioner general is the meaning of the law, only a short time will elapse until there will be hordes of dissolute women from the Orient applying for admission to this country.

Whatsoever may have been the understanding of the commissioner general of immigration, Fuku Moto is in accordance with his instructions, was released, and the order to that effect was placed in the hands of Deputy United States Marshal Quilter yesterday afternoon.

Lester F.
