Bank Receiver Church Sues County Treasurer Mish.

HOW AN EVERETT BANK FAILED

Real Estate and Notes Wanted Back—McCann Plead Not Guilty—A Plea for Divorce.

E. K. Church, receiver of the Puget Sound National bank of Everett, is after William M. Mish, treasurer of Snohomish county, and a complaint filed in Judge Hanford's court makes some startling allegations of fraud and collusion as between the county treasurer and the officers of the bank.

In his suit for the recovery of the real estate, Receiver Church says the bank became insolvent on August 7, 1895, and that he was appointed receiver. On July 17 the bank was the owner of eighty acres of land in Whatcom county and 100 acres in Mason county.

Receiver Church's other suit against County Treasurer Mish is for the recovery of promissory notes. The complaint says that the bank was on July 17, and now, the owner of certain promissory notes, which were wrongfully taken by Mish from it.

McCann Plead Not Guilty. The demurrer overruled. The probable line of defense.
