

COLLIDED IN THE FOG.

Tacoma Street Car Accident Kills a Passenger.

STRAUB REMOVES HIS COUNSEL.

A Tacoma Woman to Wed a Lord—Horrible Murder of a Japanese Woman at Salem, Or.

Tacoma, Oct. 4.—Special.—A serious street railway collision occurred at 7:30 this morning on the line of the Tacoma Traction Company near South Fifty-first street, by which one person was badly injured and several others more or less bruised and shaken up. The accident was due to a dense overhanging fog and a miscalculation by Motorman Helm and Conductor Reinhardt.

The accident occurred about 200 feet south of Hooper Junction. A car from Puyallup, in charge of Motorman Fred Foy and Conductor Harrison, arrived at the junction on time at 7:25. According to the schedule, the Edison car, in charge of Helm and Reinhardt, was to arrive at the junction ten minutes ahead of the arrival of the Puyallup car. The Edison car was ten minutes late, owing to running slow in the dense fog.

The accident occurred about 200 feet south of Hooper Junction. A car from Puyallup, in charge of Motorman Fred Foy and Conductor Harrison, arrived at the junction on time at 7:25. According to the schedule, the Edison car, in charge of Helm and Reinhardt, was to arrive at the junction ten minutes ahead of the arrival of the Puyallup car.

NO MORE SALES OF STATE LANDS

Until Better Prices Can Be Obtained at Olympia, Oct. 4.—Special.—The state land commission today passed the following important resolution:

"In view of the protests against the sale of state lands at too high, and of the fact that it is the experience of the board that little or no competition exists when land is offered for sale at public auction, and further, in view of the depressed value of real estate and that the state is not obliged to sell at the minimum price, but should endeavor to secure the maximum price, in order that the best advantage of the state may be obtained, it is ordered by the state board that no further sales of state school or granted lands be made until such advance in real estate values occurs as to justify the board in offering the lands for sale. This order shall not apply to cases where appraisals have already been ordered or in which extensions regarding the date of the sale, for some reason shall be stated in writing by the applicant, and spread upon the minutes of the board if approved."

THE STRAUB MURDER TRIAL.

Parberry to Turn State's Evidence—Straub Hires No Counsel.

Green, of Seattle, who were retained for the trial. Straub is now in custody at the state prison, and is expected to be taken to Friday Harbor for trial. The court allowed him until 9 o'clock tomorrow to get counsel.

THE AMBASSADORS PROTEST.

Complaining to the Turkish Foreign Minister of Mussulman Outrages. Constantinople, Oct. 4.—After a conference of the ambassadors today energetic representations were made to the Turkish foreign minister, complaining of the excesses committed by the Mussulman population on the prisoners and wounded on Monday and Tuesday. Many of them were dispatched with bloodgouges, while others were most cruelly maltreated. The representatives of the powers begged the foreign minister to take measures to prevent the foreign residents of Constantinople from suffering and to restore order. The United States minister, Alexander W. Terrill, also made representations to the Turkish government, requesting that steps be taken to insure the safety of the consular premises.

Mr. Hearst said at the Hoffman house that nothing had been settled in regard to the matter, but that he hoped for a satisfactory outcome.

THE POLLUTION OF AMERICAN RIVERS.

Denver, Oct. 1.—The twenty-third annual meeting of the American Public Health Association met here tonight, the president, Dr. William Bailey, of Louisville, occupying the chair. Dr. Joseph Hartzell, of Canton, O., read a paper on the Mississippi river as a sewer. Dr. Hartzell said 28,000 tons of garbage and 4,000 dead animals, suffering from glanders, tuberculosis, etc., had been thrown into the Mississippi river in one year by four cities. The Mississippi valley drained 300,000 acres, the pollution of all gradually drifting into the noble stream. "The government should put a stop to the pollution of its streams," said Hartzell, "but the average politician is not a sanitarian. Every other nation has its national board of health, and it is high time that our government followed this example."

SEATTLE WON TWO RACES.

Symbolical Career of Two Horses With Symbolical Names.

"Seattle has won two races, Tacoma's race between Seattle and Tacoma. They are being fathered respectively by Fred E. Sander and Hugh L. Thomas, both of this city. On Mr. Sander's part it is a renewal of his story of the same direction commenced a few years ago, when he was in control of the Grant street electric railway line, to extend that line to Kent and ultimately to Sunnyside. His proposition contemplated carrying out his former design or the construction of an entirely new line into the heart of the city. He has not yet secured the necessary route to the ridge between the river and the Sound as far as Sunnyside, or to run the line through Sunnyside, and thence along the ridge, bringing it down to the valley again in the vicinity of Kent.
