STOCK TO BE ASSESSED. Comptroller Eckels to Investigate Port Angeles Bank Failure.

Port Angeles, Nov. 5.-Special.-Comptroller Eckels has notified R. C. Wilson, receiver for the First National bank of this city, that he is authorized to send here to investigate matters concerning the disposition made of the bank's securities...

Mr. Wilson says that the bank now owes \$22,000, and that \$2,000 of this amount has been secured. He has in his possession \$2,000 in notes, and he says he considers them worth only about \$2,000.

It is stated that an assessment will be levied against the stockholders of the bank to cover the balance due creditors. Before the bank was closed the second one per cent of its indebtedness was liquidated and an effort was made to reorganize and continue in business, but it proved unsuccessful.

A CLERGYMAN SENTENCED.
