Y., May 22.—The Presbyterian general assembly met up at 10 o'clock this afternoon in confusion, in the midst of a vote on the resolutions of the special committee on the relations of young people's societies to the church. Resolutions had been adopted that a "statement of relations" be sent to the separate societies to be read by them, reaffirming the action of the association of 1888. The former recommendation was reached only after a long discussion, and under the operation of the previous question, just at the hour of adjournment a motion was made to strike out the other recommendations of the committee. It was carried by a majority of 20 to 10.
