**ARMY IN A FERMENT.**

**People Cry Out Against the Blunders in the War.**

**INVESTIGATIONS TO BE MADE.**

**Dark Hints of Scandal in the Management of the Army—The War Party Compelled to Defend Itself—Pierce Accusations Against the Ethnical Hetaira—The Powers Assure Greece That the Sultan Must Not Break the Armistice—Francis Joseph of Battenberg Named for Governor General of Crete.**

**LONDON, May 25.**—The correspondent of the Times at Athens says: The reports of the Turkish denunciation and bitter invective which was checked by the fear of the immediate Turkish advance to Athens has broken out afresh, now that the danger has been removed by the armistice. The authors of the war policy, equally with those who are held responsible for the disasters, are being dragged before the public opinion. So far as the official culprits are concerned, it is believed that the government may appoint a commission of inquiry to look into the guilty. A thorough investigation into the military and commissariat departments will probably entail scandalous disclosures.

The Ethnical Hetaira is bitterly denounced, and the government is urged to seize its funds, to confiscate its stores and arms, and to compel it to render an account of its management. It is not likely to accede to this suggestion, but many persons prominent in political life are closely connected with the organization, and the Hetaira, consequently, has been obliged to remain silent and to preserve its mysterious and invisible character. Possibly smitten with compunctions, however, the society has donated 90,000 drachmas for the relief of the Thessalian refugees. This is apparently the best justified item of all its expenditures.

**LONDON, May 25.**—A dispatch to the Standard from Berlin says the powers, including Turkey, have assented to the appointment of Prince Francis Joseph of Battenberg as governor general of Crete.

**CUBANS TO RAISE \$1,000,000.**

**League Will Receive Donations and Sell 6 Per Cent. Gold Bonds.**

**NEW YORK, May 25.**—The press will tomorrow publish the following: Officers of the Cuban League have decided to attempt the raising of a fund of \$1,000,000 in the United States, believing that this will enable the Cubans to establish their independence. The fund is to be raised in two ways—by donations and by the sale of gold bonds at 6 per cent, payable ten years after the evacuation of Cuba by the Spanish troops.

**HAVEMEYER IN THE DOCK.**

**Sugar Magnate Placed on Trial for Refusing to Answer**

**WASHINGTON, May 25.**—The trial of H. O. Havemeyer, president of the American Sugar Refining Company, for refusing to answer a question propounded by the senate investigating committee in the spring of 1894, began before Judge Grubb today. There was a large crowd in attendance. No trouble was experienced in securing jury, one of the twelve being a lawyer being made by the defense and none by the prosecution. District Attorney Davis conducted the case for the government and Nathaniel Wilson, John G. Johnson, of Philadelphia, and John E. Parsons, of New York, appeared for the defense.
