

NEWS FROM TACOMA.

GREAT PREPARATIONS MADE FOR THE ROSE CARNIVAL.

Air Will Be Laden With Perfume and the Streets Brilliant With Carriage and Cottage-Festivities to Be Observed in by a Civic and Military Parade of Surpassing Splendor-Formation of the Procession and Line of March.

Special Dispatch to the Post-Intelligencer. TACOMA, June 30.—Roseal Roseal never in the history of Tacoma has such preparations been made for a fête as have been in progress during the past week, and which are now arriving at the culminating point. The air tomorrow will be laden with the perfume of millions of these most beautiful flowers. No fairy queen in rhyme or song will equal the magnificence of Queen Anna, with her escort of royal maidens, the cream of Tacoma youth and beauty, and no people on earth will be more joyously and enthusiastically than the residents of the City of Destiny and the hundreds of visitors who will crowd through the city gates to assist in the observance of this loving person in this broad land of ours.

The carnival will be ushered in by a grand civic and military parade, which in point of elegance and splendor will exceed anything of a like nature ever given in the city. There will be citizen soldiers on foot and on horse, sturdy marines from Fort Stevens, and the Oregon, the veterans of the late war, sons of veterans, secret societies, floats and other features too numerous to mention. The procession will be formed on Pacific avenue and Twenty-first street, and headed by Gen. Ashton, grand marshal, will march down the avenue, which has been handsomely decorated, and out to the Annie Wright seminary, where the column will rest and form an escort to Queen Anna, who with her escort and Gov. Rogers will be in waiting. The coronation ceremonies will follow in Wright park. Queen Anna will ride in an open barouche drawn by four black horses with white saddle trappings. Her carriage decorations will be all white. Beside the queen will be the prime minister of state, Mr. Frederick Motte, president of the Chamber of Commerce. The coronation gown is an exquisite creation of heavy white satin, with a waist of tulle, white chiffon, evening, with a high De Mealy collar of accordion pleated chiffon and lace. A chequer of white satin and real lace is to be worn with the gown. The train is very long, with deep lace at the waist. The heavy, long court train is lined with pink satin and is to be edged with a garniture of similar and roses. Following the royal carriage will come the sixteen maidens of honor in a large drag decorated in red and green. These honored maids are: Miss Avis Ingersoll, Miss Amy Burnett, of Seattle, Miss Hiss Kate Lyman, Miss Helen Thomas, Miss Bertha Evans, Miss Bessie Allen, of Olympia; Miss Amy Hill, Miss Hope Grower, Miss Stella Knoble, Miss Elva Hudson, Miss Marie Howitt, Miss Joe Brown, Miss Helen Rogers, of Olympia; Miss Elsie Bennett, of Fairhaven.

The carriage containing the queen, preceded by trumpeters and escorted by the royal body guard, will be driven to the coronation stand, where her royal highness will be conducted to the throne. The royal maids will follow, and after saluting her royal highness, will seat themselves in a semi-circle upon the coronation stand. Once seated on her throne, the queen will receive Miss May Metcalfe, the floral queen, and Miss Metcalfe, the fairy floral queen and the maids in attendance on Miss Hall, Miss Florence Paddock, Miss Bessie Steyne, Miss Edna Durkin, Miss Stella Knoble, Miss Estelle Purinton, Miss Stella Church, Miss Clara Hewitt, Miss Genevieve Applegate, Miss Amelia Levitt, Miss Elvira Ingersoll, Miss Edna Bennett, Miss Elvira Clancy and Miss Margaret Tyler, all handsomely gowned in white and green. When all are in position Gov. Rogers will proclaim Miss Anna Griggs queen of the carnival of roses. Prime Minister Motte will then respond to the governor's words in behalf of her majesty, welcoming the distinguished guests and strangers to the carnival.

The parade to start at 2 o'clock will consist of four divisions, as follows: Platoon of police, in command of the chief of police; Grand marshal, in command of the parade; Marshal's staff and aides as follows: Gen. A. V. Fawcett, mayor of the city of Tacoma; chief of staff, Col. George Perry Norton, president of the Tacoma city council, chief of aides, Col. Shank, Garrison, Warner, Seel, Lee and Jacob, staff officers.

JENSEN IS DROWNED

NOTORIOUS MASTER OF THE BARK ATACAMA.

Wrecked on Easter Island With His Mate and Four Seamen, and All Are Dead—He Figured on Puget Sound Two Years Ago on a Charge of Cruelty to a Negro Sailor, and the Case Attracted Wide Attention—Alleged Owner of the Atacama Was a Wealthy Chilean Property Owner.

Special Dispatch to the Post-Intelligencer. PORT TOWNSEND, June 29.—Meager news was received from Valparaiso today of the drowning of Capt. Jensen, his mate and four seamen at Easter Island, South sea, last November. Jensen was master of the Chilean bark Atacama, which was on the Sound in 1895, and with the alleged owner, Capt. James McLean, was prosecuted and imprisoned for alleged ill-treatment of a negro sailor. The case attracted an unusual amount of attention all along the Coast, and particularly in Chile, where McLean owned property to the value of half a million dollars, and where he was manager of one of the largest towboat companies on the Coast.

TACOMA, June 30.—Chief Breumner of the fire department, who entered a vigorous protest yesterday against the appointment of George McAlevy to the position of chief of the department, has taken his case into court in the form of a petition, in which he alleges that there were irregularities in the examination, and also that the special examiners, ex-Chiefs Willis, of Tacoma, and Allen, of Seattle, entered into an agreement that whenever they could not agree on a question, they would toss up for it, or words to that effect. Judge J. H. Grout, who heard the petition yesterday, and on the allegations made issued an order restraining the civil service commissioners from certifying McAlevy until the matter before the court could be decided. This order came a little late to be effective, as McAlevy has not only been certified, but has been appointed by Mayor Fawcett, his appointment to the position of chief of the department, immediately after receiving the certification from the civil service board. This leaves nothing for Breumner to do but stop the appointment of McAlevy by the mayor, which he has done with this suit, which will take the form of a mandamus proceeding. In his petition Breumner alleges that he got a credit of \$1,500, which he should have got \$4,000, and that he got \$5,000, in winding up his complaint the chief alleges that he is informed and believes and charges as a fact that the said George McAlevy was approached by persons in authority and promised that if he would make an application for the position of chief of the Tacoma fire department, the persons in authority would see him through, that the said promises were made to the said McAlevy by Mayor Fawcett and others, and the petition charges that the said promises were made in force in the civil service commission office by means of which the petitioner was reduced in rank from first on the eligible list to which he was entitled, to fourth on the list, and that a change intended to effect that purpose after due consideration of which changes would be necessary to produce that effect, and refers to the court to evidence in the form of affidavits against deception or obstruction of any candidate by corruptly or falsely making grading, estimating or reporting on his examination.
