HANNA IS ELECTED ON FIRST BALLOT.

Combine Not Able to Disrupt His Forces. FIGHT TO THE VERY LAST. Futile Attempt to Delay the Ballot by Charges of Bribery.

HAVANA'S STREETS A SCENE OF RIOT.

Spanish Army Officers Lead an Angry Mob. TROOPS ORDERED OUT. Americans in Danger and Consulate Protected by Artillery.

United States Warships Held in Readiness to Sail for Cuba Immediately—Key West Squadron Will Be Assembled at Once—Consul General Lee Acts Promptly to Secure Protection for Citizens of This Country—Outbreak Against Newspapers Advocating Autonomy May Yet Compel Intervention.

HAVANA, Jan. 12.—At 10 o'clock this morning about 100 army officers, incensed by the violent attacks made by some of the local papers upon the general-in-chief and the principal officers of the Spanish army in Cuba, went to the printing office of the daily journals La Discusion and El Reconcentrado and began smashing the windows and destroying the printing outfit, as well as cuffing the employees.

The appearance at the office of La Discusion of Gen. Garriche, acting military commander at Havana, and Gen. Solano, chief of staff, prevented more serious outrages. The gendarmes dispersed the rioters. Order was finally established. Central park has been transformed into a military camp.

CHICAGO, Jan. 12.—A special to the Times-Herald from Key West, Fla., says: The second-class battleship Maine has received orders to hold herself in readiness to proceed to Cuba at an instant's warning. The orders came by telegraph tonight. In compliance with these orders, Capt. C. D. Sigbee, commanding the battleship, has made all arrangements to get under way without delay. He has been placed in communication with Gen. Lee, who will cable him whether or not it is necessary for him to go to Havana.
