AMERICAN PRESS DENOUNCE THE IMPOSITION OF TROJAN.

Atlantic Editors Likewise Satisfied for Ironical Articles on the Emperor's Birthday—The Reichstag Withholds Salary of Minister.

WASHINGTON, Jan. 29.—The most severe criticism has been aroused throughout the country at the sentence of two months' imprisonment in a fortress imposed upon the Emperor of Germany on Tuesday last for caricaturing the Emperor in December last by depicting Frederick the Great, Napoleon, Alexander the Great and Leonidas reading the speech of Emperor William, delivered on November 18, when he swore in the Reichstag, upon which occasion his Majesty remarked that it was necessary to give Christians in order to be good.

Even the conservative newspapers have pronounced it an atrocious sentence, and have endeavored to directly due to the Emperor's influence, as his Majesty was furious with the cartoon and has given strict instructions that Herr Trojan be confined at the same work on the charge of lese-majesty, where Herr Wroble, another caricaturist, rendered the most severe caricature of the Emperor's issue of today was contained, owing to the publication of a cartoon in which Herr Trojan satirized the Emperor's sentence. He also published two articles to the same effect in today's issue.






